

Multiple Ownership Compliance Analysis

As a result of the proposed transaction in this application, Heart of Wisconsin Media, Inc. (“HWM”) will be the licensee of 2 full-power broadcast stations listed as “home” to the Wausau-Stevens Point, Wisconsin BIA Market (“Wausau-Stevens Point Market”):

WFHR(AM), Wisconsin Rapids, Wisconsin (Facility ID No. 73053)
WLJY(FM), Nekoosa, Wisconsin (Facility ID No. 85832)

HWM is currently the licensee of WCWI(AM), Adams, Wisconsin (Facility ID No. 57267).


WFHR and WLJY are listed as “home” to the Wausau-Stevens Point Market by BIA. WCWI, however, is not listed as “home” to the Wausau-Stevens Point Market or any other BIA Market. Furthermore, as demonstrated by the map attached hereto as **Attachment A**, WCWI’s service contour does not overlap those of either WFHR or WLJY. As a result, this application demonstrates compliance with the Commission’s multiple ownership rules under only the Metro Market Methodology as the Interim Contour Overlap Methodology is not applicable.

Pursuant to the BIA Market Report attached hereto as **Attachment B**, the Wausau-Stevens Point Market is currently comprised of 29 full-power commercial and non-commercial broadcast stations. In radio markets comprised of 15-29 or more full-power commercial and non-commercial broadcast stations, Section 73.3555(a)(1)(iii) of the Commission’s rules permits licensees to own up to 6 full-power commercial broadcast stations – no more than 4 of which may be in the same service.

Accordingly, as HWM will have an attributable interest in 2 full-power broadcast stations in the Wausau-Stevens Point Market following the consummation of the above-referenced transaction, HWM will be in compliance with the Commission’s multiple ownership rules.
