The Station is committed to uploading political file material as soon as possible consistent with Commission guidance. In reviewing the political file material uploaded over the past two-years, the Station determined that a limited number of orders were not uploaded within one business day. The licensee provided training for staff responsible for uploading political file material to the online file in March 2020 to reinforce the importance of uploading all political material promptly.

Also note that the 4Q 2018 Commercial Limits Certification shows an upload date of 4/3/2019. The station originally timely uploaded this certification on 1/28/2019. See screen shot of history below. However, on April 3, 2019, a station employee while reorganizing the Children's Commercial Limits folder re-uploaded the certificate and accidentally deleted the original upload.
