AMENDMENT TO APPLICATION FOR EXTENSION OF TIME

As noted in the original application, Applicant Springfield TV, LLC recently acquired KXMP-LP (See BAL-20200413AAG) and has since acquisition been working diligently towards completing the engineering work necessary to convert to digital operations prior to the July 13, 2021 deadline for LPTV digital conversion.

At the time of the initial request, Applicant had been unable to secure financing for the equipment needed and was seeking extension pursuant to financial hardship. In the interim, Applicant has continued to pursue financing options for the equipment and has now found a commitment to finance the equipment purchase outlined below. However, the question of timing of delivery of equipment and availability of vendors to facilitate installation still may necessitate a short extension of the July 13, 2021 deadline for digital conversion.

Attached as Schedule "A" is the quotation for the selected equipment necessary for KXMP to complete the "flashcut" to digital operations. Applicant has elected to purchase from Broadcasters General Store at a cost of \$33,056.44 and has secured a closed-end equipment lease/purchase commitment for a 5 year term from a commercial lender.

Once the order is placed it is expected that delivery will occur by May 1, 2021. Applicant has been seeking qualified engineers/vendors to facilitate installation of the equipment once delivered to work with staff engineer in order to properly install the equipment and verify operational parameters to confirm digital flash cut operation, but has not received a firm commitment yet for availability prior to July, 2021.

Although Applicant fully expects to complete installation prior to July 13, 2021, in an abundance of caution it is requesting a sixty (60) day extension of the July 13, 2021 deadline in the event of a resurgence of COVID matters delays the ability to complete installation or other circumstances that prevent completion of installation.

Accordingly, Applicant requests a sixty (60) day extension to September 13, 2021 as provided in the Commission's Public Notice (DA 20-174)(released July 13, 2020) and in accordance with the provisions of 47 CFR §74.788.
