

Changes in Ownership

The Licensee, Henderson Broadcasting, L.P., is a Texas limited partnership (“Henderson Broadcasting”).

Henderson Broadcasting’s sole general partner, holding one percent of the equity, is C.M. Henderson Enterprises, L.L.C., a Texas limited liability company (“Henderson Enterprises”). Prior to the Transfer of Control, the two members of Henderson Enterprises were Charles M. Henderson and Pamela Henderson, who were husband and wife. Each held 50 percent of the equity of Henderson Enterprises. Charles M. Henderson is now deceased, and his interests have been conveyed to Pamela Henderson, who now holds 100 percent interest in Henderson Enterprises.

Prior to the Transfer of Control, Charles M. Henderson and Pamela Henderson were also limited partners of Henderson Broadcasting. Each held 49.5 percent of the partnership’s equity. Mr. Henderson’s interests have now been conveyed to Ms. Henderson, and she now holds 99 percent of the partnership’s equity.

Pamela Henderson is a United States citizen.

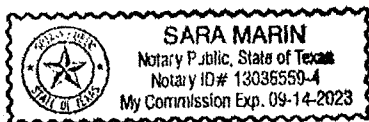

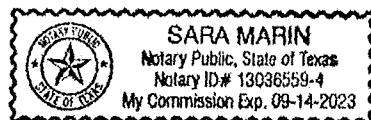
