The KBOO Foundation (“KBOO”), licensee of noncommercial educational FM station KBOO(FM), Portland, OR (Facility ID 65755); FM translator K220HR, Hood River, OR (Facility ID 33677); FM translator K242AX, The Dalles, OR (Facility ID 147659); and FM translator K282BH, Philomath, OR (Facility ID 149626) is a non-profit corporation. The KBOO Foundation is filing this application to obtain Commission consent to new members of its Board of Directors.
