Lowcountry fully intends that each of the foregoing LPTV Permits will be constructed in accordance either with the July 2021 deadline for construction or the extended deadline if granted pursuant to the corresponding station's Extension Request. In fact, some of the LPTV Permits are already under construction. Lowcountry is working on behalf of, and under the direction and supervision of, Landover to construct certain of the LPTV Permits on or before the assignment application is granted (obviating the need for the relevant Extension Requests, if construction goes as scheduled).

For the other LPTV Permits, Lowcountry has obtained quotes and projected delivery timelines from vendors for the necessary equipment. Lowcountry has also begun the process of identifying tower sites and engaging construction partners, and is conducting channel studies and engineering analyses as needed.
