

**REQUEST FOR EXTENSION OF CP DEADLINE**  
**AND FOR**  
**WAIVER OF DEADLINE FOR FILING OF CP EXTENSION REQUEST**

Pursuant to FCC Public Notice, DA-20-724, released July 13, 2020<sup>1</sup>, Freelancer Television Broadcasting, Inc. (“Freelancer”), permittee of the low power television construction permit for WLLZ-LD (File No. 0000071863, Facility ID 16651), hereby requests a six month extension of time to complete construction of the facility, along with a waiver of the deadline for filing a CP Extension Request.

The Commission’s Reminder PN states the requirement of a good cause showing for any extension request that demonstrates failure to meet the construction deadline “due to circumstances that are either unforeseeable or beyond the licensee’s control and that the licensee has taken all reasonable steps to resolve the problem expeditiously. Such circumstances include “inability to obtain equipment.” (Reminder PN at 1.) That is the case here. This filing has been necessitated by a recent discovery, made during the process of installing the new digital antenna, that one additional part – a connector flange – was needed. Specifically, on May 10, 2021, Freelancer’s vendor Northern Tower Erection Company (“Northern Tower”) alerted Freelancer that the connector flange installed on the transmit antenna does not match the connector that is on the line, and that the connector needs to be replaced. Freelancer approved the ordering of a new flange on May 12<sup>th</sup>. On June 17<sup>th</sup>, Northern Tower informed Freelancer that the connector flange remained on backorder for at least another month. Accordingly, a flange was ordered from a new vendor on June 17<sup>th</sup>. *See* the attached documentation.

Timeline: The vendor of the flange stated that the equipment can be shipped after July 9<sup>th</sup>. The exact date of delivery is unknown at this time, but hopefully will occur in July. Once the part is obtained, it is unknown at this time exactly when Northern Tower can schedule installation and completion of construction, but Northern Tower has stated that once tower work is scheduled, installation and completion of construction can be concluded within one day. Freelancer hopes that that construction can be completed by some time in September.

While Freelancer believes the above timeline to be accurate, it cannot control the events in that timeline. Accordingly, Freelancer seeks a six month extension to cover a worst-case scenario, thus avoiding having to impose more burden on Commission staff by seeking an additional extension if a shorter extension were requested but further delays not in Freelancer’s control occur.

<sup>1</sup> That Public Notice, and the subsequently issued public notice issued on March 4, 2021 on the same topic, reminded Low Power Television and Television Translator Stations of July 13, 2021 Digital Transition Date. In that Public Notice (the “Reminder PN”), the FCC also provided, in part, “In addition to ceasing analog operations by the digital transition date, transitioning LPTV/translator stations that experience delays in completing their digital facilities may seek one last extension of time of their digital construction permits, of not more than 180 days, to be filed no later than March 13, 2021, which is four months prior to the July 13, 2021, transition date.

In addition to an extension of the CP construction deadline, Freelancer seeks a waiver of March 13<sup>th</sup> deadline for filing for such extension. Section 1.3 of the Commission's rules authorizes waivers upon a showing of good cause. Section 1.925(b)(3)(ii) of the Commission's rules authorizes waivers where "[i]n view of unique or unusual factual circumstances of the instant case, application of the rule(s) would be inequitable, unduly burdensome or contrary to the public interest, or the applicant has no reasonable alternative." The present case meets both standards.

In regards to the request for waiver of the March 13<sup>th</sup> filing deadline, Freelancer had no need to file at that time, since it was prepared to complete construction and commence operations prior to the July 13<sup>th</sup> construction deadline. Because it only learned of the unworkable flange in May, and immediately took diligently took steps to correct that, denial of this waiver request would be inequitable and unduly burdensome, and contrary to the public interest in Freelancer providing its over-the-air TV service to the public. Freelancer had no reasonable alternative.

As reflected above, Freelancer has been hindered by a circumstance beyond its control, but continues to diligently move forward in good faith. Freelancer respectfully requests a six month extension of its construction permit until January 12, 2022.

Unfortunately the connector we need for the line at the antenna is on backorder. When I placed the order over a month ago the lead time was 30 days. CommScope is now telling my vendor another month. I am working on trying to find it from another vendor. If you have any contacts that might have one the part number is CommScope H7FB-110-S

Alternatively, maybe it would be faster to ship the antenna back to the manufacturer and have a connector put on that matches the existing connector on the line.
