

PURPOSE OF AMENDMENT

The instant construction permit extension request is hereby being amended to attach a letter from Roseland Broadcasting, Inc. ("Roseland"), the proposed Assignee of the low-power television ("LPTV") station construction permit to which this extension request pertains (See LMS File Nos. 0000137177, 0000135781, 0000135784, 0000136044, 0000136256, 0000135958, 0000136213, 0000136103, 0000135964 and 0000135840).¹ The letter certifies Assignee's intent to construct the LPTV stations within the applicable construction deadline. It should also be noted that Roseland, with the consent of the permittee, shall be filing modification applications -- in particular, to address those permits which are out of core.

No other changes to the extension request are being made herein.

Roseland Broadcasting, Inc. ("Roseland") is the proposed assignee (See LMS File Nos. 0000151350 and 0000152331) for the low-power television station construction permits listed in the attached chart ("LPTV Permits"), each of which has pending a request for extension ("Extension Request").

Roseland fully intends that each of the LPTV Permits will be constructed in accordance with the extended deadline if granted pursuant to the corresponding LPTV Permit's Extension Request. Roseland is working on behalf of, and under the direct supervision of the current permittee to initiate construction of the LPTV Permits.
