KNOW ALL PERSONS BY THESE PRESENTS that:

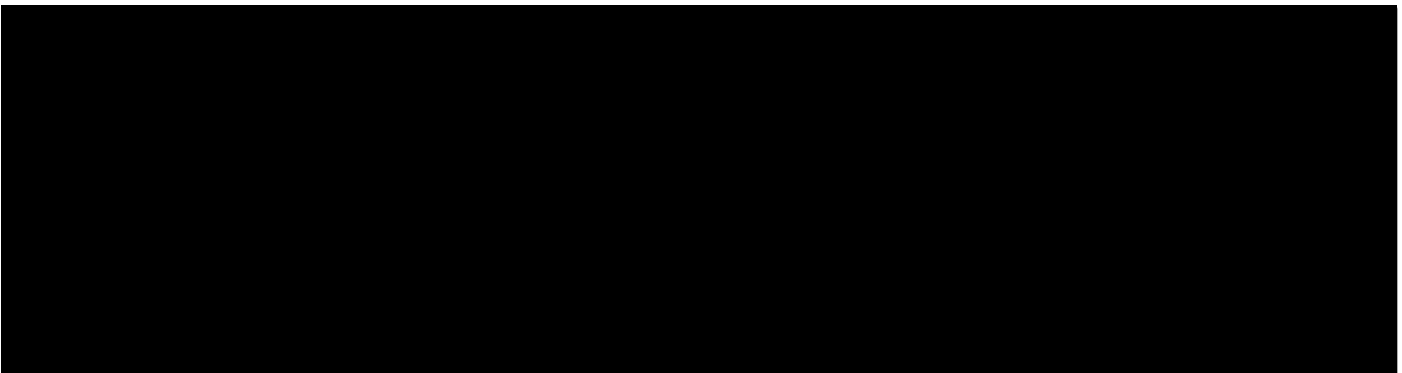

WHEREAS, the May 26, 1998 Agreement was amended on January 21, 2004 and January 26, 2006, amended and restated on December 9, 2008 and amended on May 27, 2010 and amended and restated on March 21, 2013; and

WHEREAS, GEORGE G. BEASLEY now desires to further amend and restate the May 26, 1998 Agreement, as heretofore amended and restated, in its entirety, as hereinafter set forth.

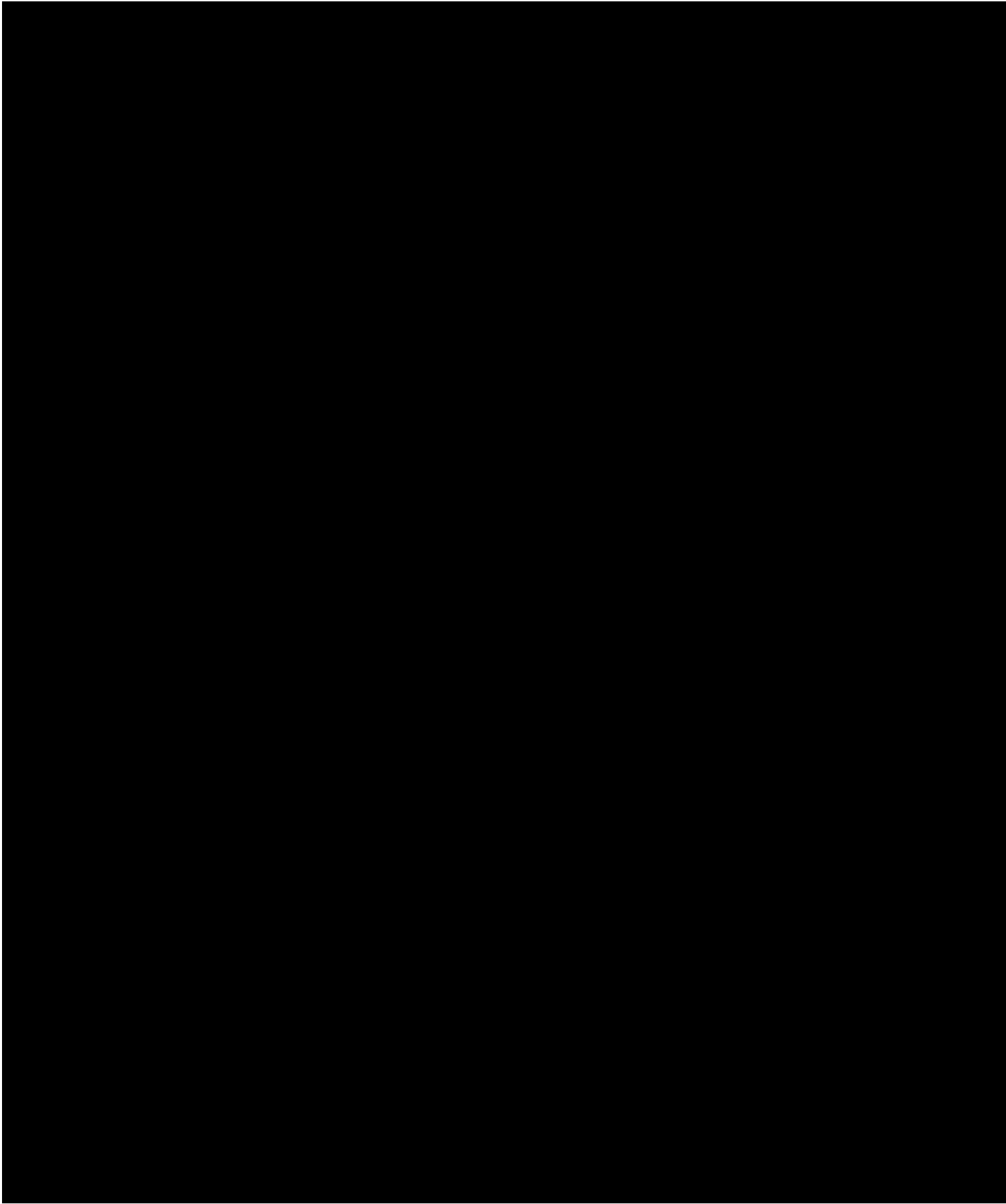

**SEVENTH AMENDMENT TO THE

WHEREAS, by Declaration of Trust dated May 26, 1998, made by GEORGE G. BEASLEY, as both "Grantor" and "Trustee," a trust was created of certain property (hereinafter referred to as the "May 26, 1998 Agreement");

WHEREAS, GEORGE G. BEASLEY, as Grantor, reserved the right under the May 26, 1998 Agreement, by an instrument in writing, signed, acknowledged and delivered to the Trustees, to alter, amend, and modify the May 26, 1998 Agreement in any and every respect, and to revoke, cancel and annul the May 26, 1998 Agreement or any trust thereby created, in whole or in part;

WHEREAS, the May 26, 1998 Agreement was previously amended on January 21, 2004 and January 26, 2006, amended and restated on December 9, 2008, amended on May 27, 2010, and amended and restated on May 21, 2013 and again on October 13, 2014; and

WHEREAS, GEORGE G. BEASLEY, as Grantor, now desires to further amend the May 26, 1998 Agreement, as heretofore amended and restated.

NOW, THEREFORE, GEORGE G. BEASLEY, the Grantor, hereby amends the May 26, 1998 Agreement, as heretofore amended and restated, as follows:

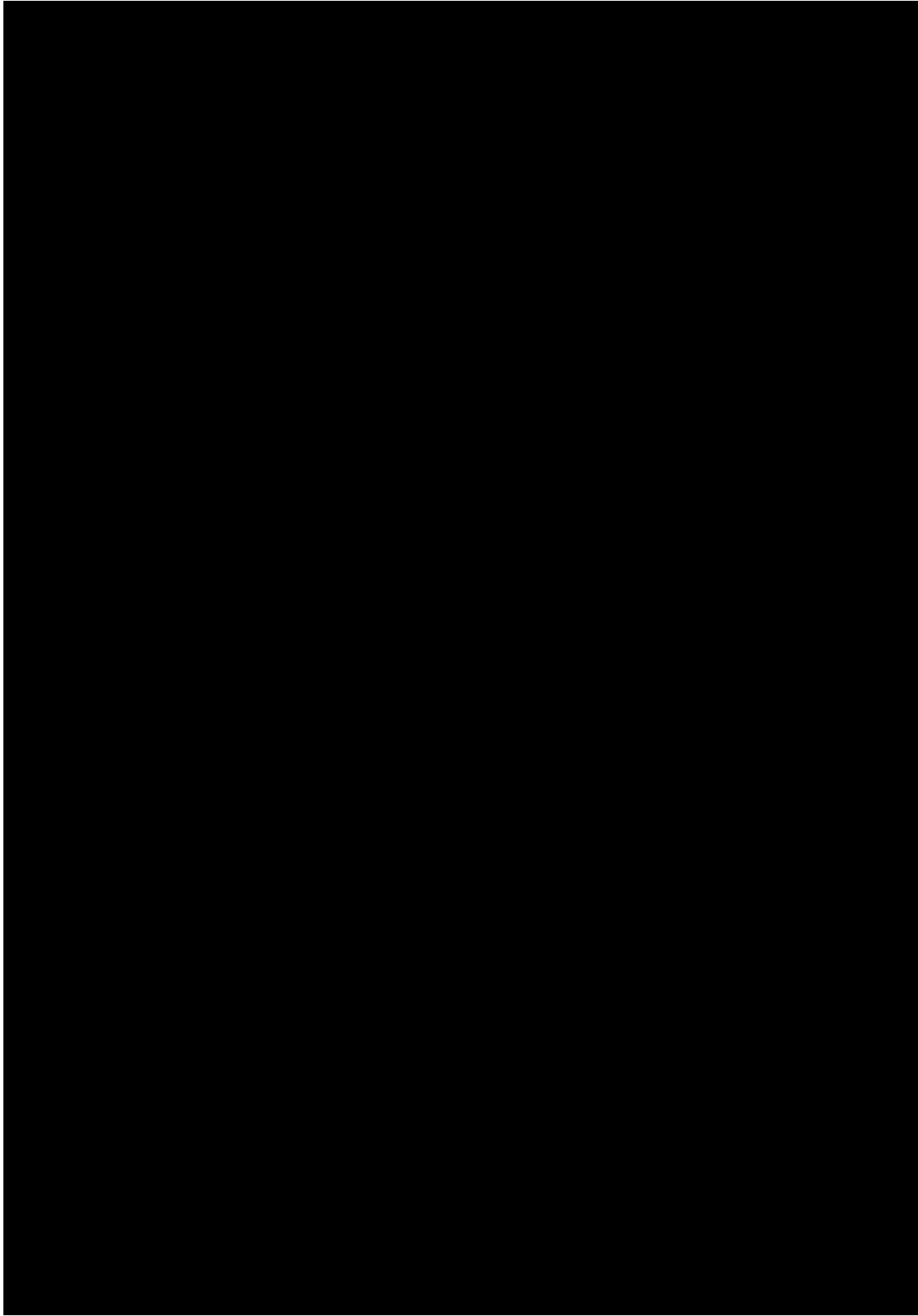
FIRST: The Grantor hereby revokes and deletes Article VI of the May 26, 1998 Agreement, as heretofore amended and restated, and substitutes in lieu thereof the following:


Article VI. Appointment of Fiduciaries.

My spouse, SHIRLEY ANN BEASLEY, and my children,
BARBARA CAROLINE BEASLEY, BRUCE G. BEASLEY,
BRADLEY C. BEASLEY, BRIAN E. BEASLEY and ROBERT E.

BEASLEY, shall become co-Trustees, to act together with any other then acting Trustee, upon the first to occur of the following events:

- A. Appointment by me;
- B. My death;
- C. A total vacancy in the office of Trustee; or
- D. Such time that I am incapacitated.





SECOND: Except as herein amended, GEORGE G. BEASLEY hereby ratifies and confirms the May 26, 1998 Agreement in its entirety.






