

Reason for Reinstatement/Extension

The existing Engineering STA for WSJN-CD (LMS File No. 0000058620, as most recently extended by LMS File No. 0000141551) inadvertently lapsed. Licensee hereby requests reinstatement of the STA facility previously granted.

Wanda Rolon, licensee of WSJN-CD, San Juan, Puerto Rico (Facility ID No. 48239) (“WSJN-CD”), was previously granted Special Temporary Authority (“STA”) for WSJN-CD to commence operations on its post-auction Channel 22 with interim facilities because the station’s tower was completely destroyed by Hurricane Maria. *See* LMS File No. 0000058620. Ms. Rolon previously requested extensions of WSJN-CD’s STA while the station worked diligently to construct a new tower, and buildout its repack construction permit. *See* LMS File Nos. 0000067224, 0000079890, 0000103855, 0000107621, 0000121818, and 0000141551.

Despite the tower’s destruction in the wake of Hurricane Maria, the numerous earthquakes and aftershocks that followed, and the onset of the COVID-19 pandemic in Puerto Rico which caused Licensee’s substantial decline in financial income, Licensee has continuously worked as diligently as possible to construct WSJN-CD’s new tower. Specifically, the Geotechnical Exploration study for WSJN-CD was completed on February 25, 2020, the WSJN-CD Land Survey was completed on February 20, 2020, and the tower structure analysis quote was requested on March 3, 2020.

The most recent STA extension for WSJN-CD was granted by the Commission on April 28, 2021. Since that time, Licensee has continued working diligently to organize and finalize the construction of WSJN-CD’s new tower. Accordingly, additional significant progress in construction has been made, but the final tasks necessary to complete the tower’s buildout remain. Specifically, during this time H&C Communications, Licensee’s construction company for the tower replacement (“H&C”), has been working on preparations for the arrival of the new tower, including constructing the galvanized steel beams to support the tower base, reinforcing the anchors base plate, and installing new ground rods. The project was temporarily halted in early July, 2021 while H&C secured the necessary Certificate of Liability Insurance (the “COI”) required by the Licensee complete construction. The COI was subsequently obtained, with a copy attached hereto.

Further, the tower and its accessories have been purchased from El Paso Communications Inc., but its shipment to Puerto Rico has since been delayed. H&C expects delivery by the first week of August, 2021, barring no further delivery delays due to the ongoing effects of the COVID-19 pandemic (such as equipment shortages and travel restrictions). Upon delivery of the tower and equipment, H&C estimates that the timeframe to complete the replacement and setup will take approximately five days thereafter.

Given the facts described herein, Ms. Rolon hereby requests a further extension of WSJN-CD's STA to operate with interim facilities while construction of the station's new tower and facilities are completed.
