


ALLOCATION STUDY

The attached map exhibit shows the service and interference contours for the proposed KSRP facilities in relation to those of all other domestic stations, both operating and proposed, on Channels 203 through 209 that require protection consideration. All contours were projected using the notified facilities for each station from the FCC's Licensing and Management System ("LMS") and terrain data extracted from the NGDC 30 second terrain database. As shown in this figure, the proposed KSRP facilities will not cause or receive any prohibited contour overlap with any other station that requires protection consideration.

The attached table shows the actual and required separations between the proposed KSRP facilities and all stations and allotments operating on Channels 259 and 260. As shown in this table, the proposed KSRP facilities are fully spaced to all stations operating or proposed.


