APPLICATION FOR LICENSE

The following engineering statement has been prepared for **Digital Networks-Midwest, LLC** (“Midwest”), licensee of digital low power television station K36QD-D at Norfolk, Nebraska, and is in support of their application for license to cover the authorized modification to the facility.¹ This application is being filed to cover the construction permit assigned LMS File No. 0000157809. Also proposed under this application is a change in the community of license from Norfolk, Nebraska to Omaha, Nebraska.

Under the referenced construction permit, K36QD-D is authorized to operate on television channel 36 with a maximum effective radiated power of 2.0 kW at a center of radiation of 580.6 meters above mean sea level, 83.8 meters above ground, utilizing a composite directional antenna. The composite antenna consists of two Kathrein-Scala PR-TV antennas. One of these antennas is oriented at 100 degrees true, while the other is oriented at 350 degrees true. Equal power division is employed between both antennas. Midwest has completed construction of the facility utilizing the authorized parameters. The installed equipment achieves the authorized effective radiated power.

The construction permit, as issued by the Commission, lists one special condition or restriction. This condition advises Midwest that the authorization is a Low Power Television authorization, and as such, is secondary. Midwest is cognizant of the interference requirements imposed on it by the authorization, and will comply, as required.


