

Description: NATURE OF TRANSFER

LANE COLLEGE IS A NON-STOCK CORPORATION CONTROLLED BY A BOARD OF TRUSTEES, CONSISTING OF 25-27 MEMBERS. AFTER AN APPROVAL OBTAIN ON FCC FORM 315 (BTCL-20171219ACK), THERE ARE SOME PREVIOUS BOARD MEMBERS WHO ARE NO LONGER ON THE BOARD. THE NUMBER OF BOARD MEMBERS WHO WERE INCLUDED IN THE 2017 LONG FORM TRANSFER APPLICATION HAS CHANGED SUCH THAT LESS THAN 50% OF THE PREVIOUS 2017 BOARD REMAINS ON THE 2021 BOARD..

THIS APPLICATION SEEKS CONSENT FOR TRANSFER OF CONTROL OF THE PREVIOUS CONTROL GROUP (2017 BOARD) TO THE NEW CONTROL GROUP (CURRENT 2021 BOARD OF TRUSTEES).

THE TRANSFEROR SECTION OF THIS APPLICATION CONTAINS A LIST THE TRUSTEES WHO ARE NO LONGER ON BOARD, AND THUS 'TRANSFERRED' THEIR VOTING RIGHTS TO THEIR SUCCESSOR.
