

**AMENDMENT TO TIME BROKERAGE AGREEMENT**

THIS AMENDMENT TO TIME BROKERAGE AGREEMENT (this “*Agreement*”) is made as of 18th day of October, 2021, by and between **WP BROADCASTING, LLC**, a Washington limited liability company (“*Licensee*”) and **EXCITER MEDIA, LLC**, a Texas limited liability company (“*Programmer*”).

Recitals

A. Licensee owns and operates Commercial Radio Stations KRSY (AM) 1230 kHz, Alamogordo, New Mexico (FCC Facility ID No.14029), KRSY (FM) 92.7 MHz, La Luz, New Mexico (FCC Facility ID No. 14028), and KNMZ (FM) 103.7 MHz, Alamogordo, New Mexico (FCC Facility ID No. 14030) and holds a construction permit for unbuilt translator K270CS (collectively, the “Stations”), issued by the Federal Communications Commission (the “FCC”).

B. Programmer has available and is producing radio programs that it desires to have broadcast on the Stations, and therefore desires to purchase airtime from Licensee for the broadcast of such programs.

C. Licensee has agreed to make available to Programmer airtime on the Stations and accept for broadcast the programs of Programmer on the terms and conditions set forth in this Agreement.

D. Licensee and Programmer, (as “Seller” and “Buyer,” respectively) are parties to an Asset Purchase Agreement (“APA”) and Real Estate Purchase Agreement (the “REA”), each executed October 18, 2021, whereby Programmer would purchase the assets and licenses of the Stations and the real estate where the principal office for the Stations is located.

E. Licensee and Programmer desire to amend this Agreement as set forth below. No other changes to the Agreement are being made hereby.

Agreement

NOW, THEREFORE, taking the foregoing recitals into account and in consideration of the mutual covenants and agreements contained herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties, intending to be legally bound, hereby agree to substitute the following Section 1 of this Agreement for the corresponding Section now in effect:

1. Term. The term of this Agreement (the “Term”) began at 12:01AM on August 1, 2021 (the “Commencement Date”), which is also the effective date, and will continue until consummation of the transactions contemplated by the APA (unless earlier terminated pursuant to this Agreement, or the terms of the APA.)
