

**AUCTION DISCLOSURE INFORMATION**

The applicant, iHM Licenses, LLC (“iHM Licenses”), has not entered into any consortium arrangements, joint ventures, partnerships or other agreements or arrangements relating to the competitive bidding process for Auction 109 prior to the time bidding was completed. The applicant did not enter into any explicit or implicit agreements, arrangements or understandings of any kind with any parties regarding the amount of its bids, bidding strategies, or the particular construction permits on which it did or did not bid.

The applicant, iHM Licenses, is a Delaware limited liability company (“LLC”). iHM Licenses’ sole (100%) member is iHeart Media + Entertainment, Inc. (“iHM+E”), a Nevada corporation. iHM+E’s sole shareholder is iHeart Operations, Inc. (“iHO”), a Delaware corporation. iHO’s sole shareholder is iHeartCommunications, Inc. (“iHC”), a Texas corporation. iHC’s sole shareholder is iHeartMedia Capital I, LLC (“iHM Capital I”), a Delaware LLC. iHM Capital I’s sole member is iHeart Media Capital II, LLC (“iHM Capital II”), a Delaware LLC. iHM Capital II’s sole member is iHeartMedia, Inc. (“iHeart”), a Delaware corporation. Each of iHM Licenses, iHM+E, iHO, iHC, iHM Capital I, iHM Capital II, and iHeart (collectively the “iHeart Entities”) use the address 7136 S. Yale Avenue, Suite 501, Tulsa, Oklahoma 74136.

- PIMCO Funds: PIMCO Income Fund (“PIMCO Income Fund”), a Massachusetts trust with an address of P.O. Box 55060, Boston, MA 02266-5060. PIMCO Income Fund holds a greater than ten percent direct ownership interest in iHeart.
- Pacific Investment Management Company LLC (“PIMCO”), a Delaware LLC with an address of 650 Newport Center Drive, Newport Beach, CA 92660. PIMCO holds a greater than 10% indirect ownership interest in iHeart as an investment manager for PIMCO Income Fund and other PIMCO-managed funds and accounts that hold common stock in iHeart.

- Allianz Asset Management of America L.P. (“AAMA LP”), a Delaware limited partnership with an address of 650 Newport Center Drive, Newport Beach, CA 92660. AAMA LP holds controlling equity and voting interests in PIMCO.
- Allianz Asset Management of America LLC (“AAMA LLC”), a Delaware LLC with an address of 650 Newport Center Drive, Newport Beach, CA 92660. AAMA LLC holds controlling equity and voting interests in AAMA LP.
- Allianz Asset Management of America Holdings, Inc. (“AAMA Holdings”), a Delaware corporation with an address of 650 Newport Center Drive, Newport Beach, CA 92660. AAMA Holdings holds a controlling voting interest in AAMA LLC.
- Allianz of America, Inc. (“Allianz of America”), a Delaware corporation with an address of 1465 N. McDowell Boulevard, Suite 100, Petaluma, CA 94954. Allianz of America holds a controlling equity interest in AAMA LLC.
- Allianz Asset Management GmbH (“Allianz GmbH”), a German LLC with an address of Seidlstrasse, 24-24a, Munich, Germany D-80335. Allianz GmbH holds controlling voting and equity interests in AAMA Holdings.
- Allianz Europe B.V. (“Allianz Europe”), a Netherlands non-public LLC with an address of Keizersgracht 484, Amsterdam, Netherlands 1017EH. Allianz Europe holds controlling voting and equity interests in Allianz of America.

- Allianz SE (“Allianz”), a European public company with an address of Koniginstrasse 28, Munich, Germany D-80802. Allianz holds controlling voting and equity interests in Allianz GmbH and Allianz Europe.

One or more of the parties identified in this exhibit, by virtue of their interests in the iHeart Entities, are deemed to hold a ten percent or greater interest in certain iHeart Entities and in the following FCC-regulated entities that are affiliates of iHeart:

- iHeart Management Services, Inc. (principal business: management services)
- Los Angeles Broadcasting Partners, LLC (principal business: radio broadcasting)
- Premiere Networks, Inc. (principal business: radio broadcasting)
- TTWN Networks, LLC (principal business: traffic reporting)

Other than the iHeart Entities and the affiliates listed above, no individual or entity disclosed in this exhibit holds a ten percent or greater ownership interest in any FCC-regulated business.

iHM Licenses did not claim a bidding credit in Auction 109 and does not claim status as a “designated entity.” Accordingly, Sections 1.2110(j) and 1.2112(b) are not applicable to iHM Licenses or this application.
