HYDE PARK, VERMONT – 205A

STATEMENT ON FIRST AND SECOND NCE SERVICE

The proposed operation will provide service to 8353 persons in an area of 200.7 square kilometers within its 60 dBu f(50,50) contour.

Three other NCE facilities provide 60 dBu service to portions of the proposed service area. The three facilities are:



The attached Figure 3 is a plot showing the relationship of the proposed 60 dBu contour and the 60 dBu contours of the listed facilities. Inside the proposed 60 dBu contour there are ten distinct areas delineated by the overlapping contours of the listed facilities. Each of these areas is labeled A through J (in blue) and the number of current NCE services, for each area, is shown (in red).

The attached Table 2 lists each of the areas, the existing service in each area and the population of each area. As shown in Table 2, the proposed operation will provide a first NCE service to 422 persons, a second NCE service to 1739 persons and an aggregate first and second NCE service to 2161 persons.

All population counts were made using U.S. Census Bureau 2010 centroid data as provided by RadioSoft's Comstudy. All area calculations are based upon 72 equally spaced radials as determined by RadioSoft's Comstudy.
