

Credit for Local Applicant

Nantucket Public Radio, Inc. ("NPR") qualifies for points as an established local applicant for several reasons. First, Ms. Lois Shapiro, the sole member of NPR, resides at 57 Pocomo Road, Nantucket, Massachusetts, 02584 within the community of license for NPR. Second, the principal office for NPR is 19 Old South Road, Suite 18B, Nantucket, Massachusetts 02554. Third, the Articles of Incorporation as amended requires the corporate headquarters for NPR to be physically headquartered or have 75% of NPR's board members reside within 25 miles of the reference coordinates for Nantucket. Attached are the three most recent annual reports for NPR showing that Ms. Shapiro has resided in Nantucket and the headquarters for NPR has been in Nantucket for at least the past two years. Also attached is an Amendment to the Articles of Incorporation dated October 10, 2007 requiring the physical presence of NPR's headquarters and 75% of NPR's board members reside within 25 miles of Nantucket. Consequently, NPR qualifies for credit for a local applicant.

That Article IV is hereby amended by the addition of the following:

At all times, the Corporation shall: (a) be physically headquartered, or (b) have a campus, or (c) have 75 percent of its board members reside within 25 miles of the reference coordinates of the community to be served by a new noncommercial radio station for which the Corporation files a construction permit application. The Corporation shall take no action which would disqualify the Corporation as a noncommercial licensee holding a broadcast license.

The foregoing amendment(s) will become effective when these Articles of Amendment are filed in accordance with General Laws, Chapter 180, Section 7 unless these articles specify, in accordance with the vote adopting the amendment, a *later* effective date not more than *thirty days* after such filing, in which event the amendment will become effective on such later date.
