Dear Applicants:

This concerns the above-referenced applications for new low power television stations filed by Spanish Broadcasting System Holding Company, Inc. (SBS) and Telecinco, Inc. (Telecinco). You have submitted a settlement agreement to resolve the mutual exclusivity among these applications in MX Group 018 in Auction 111.¹ Pursuant to the settlement agreement, SBS has agreed to dismiss its two applications in exchange for repayment of its legitimate and prudent expenses. In addition, Telecinco has submitted an engineering amendment that resolves the mutual exclusivity between its two remaining applications. These actions will resolve the mutual exclusivity among the applications in MX Group 018.

Upon review of your settlement agreement, engineering amendment and related documents, we find that it complies with section 311(c) of the Communications Act, section 73.3525 and the Commission's technical rules.

BNPDL-20090825BRB and BNPDL-20090825BRF) **ARE DISMISSED**.
