Dear Mr. Bradshaw:

Prior to 6 PM this evening, I attempted to submit an application in the NCE FM window. The application was complete, with all exhibits uploaded and the certification section complete, however, the screen went blank and I was unable to submit it. I tried to refresh the screen and to log back into the system and was unable to do so. Another attorney in my office also attempted to log in and was unable to do so. I was able to both email FCC staff and look up the number for and call the FCC's help desk prior to 6 PM to alert them of the issue. I continued to attempt to log into the system, as did another attorney in my office. We were each using different browsers. Neither of us was able to log in again until approximately 13 minutes after 6 PM. At that time, the system appeared to be working normally and allowed me to access all sections of the form. Accordingly, I attempted to file the application, but received a message that the application could not be filed outside of a specified filing window.

Accordingly, as the application was in the process of being submitted when the LMS system went down, and would have been submitted timely but for the temporary unavailability of the LMS, it is respectfully requested that the application be accepted as timely by the 6 PM deadline and be considered in the NCE FM application window for all purposes.
