Dear Applicant:

Pursuant to 47 CFR § 73.1015, we are undertaking a review of the basic qualifications underlying the referenced applications (Applications) filed by Centro Cristiano de Vida Eterna San Antonio (CCSA) on FCC Form 2100, Schedule 340 (FCC Schedule 340). We require a response to this letter within 30 days.

**1. Reasonable Assurance of Site Availability.**

The instructions to FCC Schedule 340 specify:

**Reasonable Site Assurance.** All applicants for broadcast facilities must have a reasonable assurance that the specified site will be available **at the time they file the FCC application**. See *William F. and Anne K. Wallace*, 49 FCC 2d 1424, 1427 (Rev. Bd. 1989); *Genesee*

*Communications, Inc.*, 3 FCC Rcd 3595 (1988). Applicants filing this FCC Schedule 340 must certify that the site specified in the application is available for its intended use. If reasonable assurance is not based on the applicant's ownership of the proposed site or structure, the applicant must certify that it has obtained reasonable assurance of the site's availability by contacting the owner or person possessing control of the site or structure. The applicant must specify the name of the person contacted, the person's telephone number, and whether the contact is the tower owner, agent, or authorized representative.

In each of its Applications, CCSA certified "Yes" to having reasonable assurance of site availability. For the Gonzales, TX application, provide a response to the information from the tower site owner set forth in Exhibit 1.

In addition, for each of the Applications, please **provide the following information and documents to the extent that they were in existence as of the time each Application was filed:**

- (a) All documents (including written and electronic documents such as text messages, emails, letters, notes) in the possession of CCSA and its agents relating to the availability of the proposed site for each Application or the reason(s) for selecting that site; and
- (b) The name, telephone number and email address of each person contacted by CCSA and its agents in connection with the availability of the proposed site for each Application, and in each case specify that person's connection to the proposed site.

## **2. Financial Qualifications.**

In each of its Applications, CCSA certified "Yes" to indicate that "sufficient net liquid assets are on hand or that sufficient funds are available from committed sources to construct and operate the requested facilities for three months without revenue." For each of the Applications, please **provide the following information and documents to the extent that they were in existence as of the time each Application was filed:**

- (a) All cost estimates, budgets, budget estimates and related calculations of the cost of constructing each proposed station and operating each such station for the first three months of operation;
- (b) All documents (including written and electronic documents such as text messages, emails, letters and notes) that CCSA relied upon to certify that sufficient net liquid assets are on hand or are available from committed sources to construct and operate each such station for the first three months of operation.

## **INSTRUCTIONS FOR THE RESPONSE**

This letter constitutes an order of the Commission to produce the documents and information requested herein.<sup>1</sup> To knowingly and willfully make any false statement or conceal any material fact in reply to this inquiry is punishable by fine or imprisonment.<sup>2</sup> **Failure to respond appropriately to this letter constitutes a violation of the Act and our rules and may result in dismissal of the Applications.**<sup>3</sup>

**CCSA's response to this letter is due within 30 days of the date of the letter.** CCSA shall submit its response electronically via e-mail to [tom.hutton@fcc.gov](mailto:tom.hutton@fcc.gov) and [alexander.sanjenis@fcc.gov](mailto:alexander.sanjenis@fcc.gov). Thee electronic response shall be produced in a format that allows the Commission to access and use it, together with instructions and all other materials necessary to use or interpret the data, including record layouts, data dictionaries, and a description of the data's source. If the response will exceed 5MB, you must first contact the FCC addressees listed above for alternative filing instructions.

***Affidavit Requirement.*** We direct CCSA to support its response with an affidavit or declaration under penalty of perjury, signed and dated by an authorized director of CCSA with personal knowledge of the representations provided in CCSA's response. The affidavit or declaration must verify the truth and accuracy of the information therein, state that all of the information requested by this letter that is in CCSA's possession, custody, control, or knowledge has been produced, and state that any and all documents provided in its responses are true and accurate copies of the original documents. In addition to such general affidavit or declaration of the authorized director of CCSA described above, if such person (or any other affiant or declarant) is relying on the personal knowledge of any other individual rather than his or her own knowledge, and if multiple CCSA representatives contribute to the response, CCSA shall provide separate affidavits or declarations of each such individual with personal knowledge that identify clearly to which responses the affiant or declarant with such personal knowledge is attesting. All such declarations provided must comply with section 1.16 of the Commission's rules,<sup>4</sup> and be substantially in the form set forth therein. Failure to support your responses with a sworn affidavit could subject you to forfeiture.<sup>5</sup>

Attached is an email thread between Vertical Bridge Broadcast Leasing and the applicant in this matter. The applicant did approach Gary Hess asking for reasonable assurance but were told that the tower in question did not have adequate structural capacity and no space was available. They later contacted Joe Meleski with the same inquiry and Joe reiterated that space on the tower was not available. The applicant then asked to be placed in a queue to be considered if and when the tower would be modified. That email was not responded to.

Vertical Bridge maintains that reasonable assurance was not and is not offered to the applicant on this tower.

I had initially sent this to Steven DeSena since we have been working with him regarding an unbuilt paper TV station - WYMI claiming to be operating from our tower located at Cudjoe Key, FL

Good morning Steven,

Vertical Bridge owns the tower in this recent NCE filing. The applicant contacted Vertical Bridge regarding reasonable assurance and Gary Hess responded that the tower is at capacity and no reasonable assurance was being offered. The email thread below shows that the applicant asked another leasing manager the same question and Joe Meleski responded the same – that the tower is at or over capacity. The applicant's final inquiry regarding being placed in a queue to consider should the tower capacity be increased was not responded to. The applicant included a contact with American Tower in support of reasonable assurance in their filing but American Tower does not own this site.

Vertical Bridge maintains that reasonable assurance was not obtained for this tower by this applicant.
