

Other Authorizations of Assignee and Attributable Parties to Assignee

This application is one of two assignment applications being filed concurrently for Commission consent for Major Keystone LLC to acquire AM and FM Translator stations that are the subject of a single Asset Purchase Agreement. The AM and FM Translator stations for which Major Keystone LLC is the proposed Assignee are:

- WIOV(AM), Reading, Pennsylvania, Facility ID 55307
- WARM(AM), Scranton, Pennsylvania, Facility ID 70504
- WGLD(AM), Manchester Township, Pennsylvania, Facility ID 55352

Major Keystone LLC intends to continue to rebroadcast the currently associated primary stations on the foregoing FM Translator Stations. Specifically, FM Translator W253CK, Reading, Pennsylvania, Facility ID 200867, will continue rebroadcasting primary station WIOV(AM), Reading, Pennsylvania, Facility ID 55307; FM Translator W296EA, Manchester Township, Pennsylvania, Facility ID 200873, will continue rebroadcasting WGLD(AM), Manchester Township, Pennsylvania, Facility ID 55352.

At present, Major Keystone LLC does not hold the licenses of any full-service broadcast stations. Major Keystone LLC currently is the licensee of FM Translator stations W268BB, State College, Pennsylvania, FCC Facility ID 155828, and W275DI, Reading, Pennsylvania, FCC Facility ID W257DI.

Major Keystone LLC provides programming via a Local Programming and Marketing Agreement for two full-service AM radio stations: WEST(AM), 1400 kHz, Easton, Pennsylvania, FCC Facility ID No. 36996, and WHOL(AM), 1600 kHz, Allentown, Pennsylvania, FCC Facility ID No. 36987 (which are rebroadcast on associated FM translator stations). These AM stations are home to the Allentown-Bethlehem, PA Nielsen Metro market.
