

## **Acquisition of Control**

It is the understanding of Transferee that in the case of an involuntary transfer of control of a broadcast licensee due to the death of the licensee's majority stockholder, the transferee need not have had his/her qualifications previously passed upon by the Commission. In any event, it is the case that the Transferee, Matthew Mnich, has had his qualifications previously passed upon by the Commission.

Specifically, North American Broadcasting Company, Inc. ("NABCo"), the licensee, acquired Station WJKR(FM), Worthington, Ohio (formerly WEGE, Westerville, Ohio), FCC Facility ID No. 60099, from Davis Broadcasting Co Ltd., as authorized by the Commission via submission of an application on Form 314 (long-form assignment application), File No. BALH-19981119GR. See attached Consent to Assignment. As reflected in Commission records, this Form 314 application was filed on November 19, 1998, was granted by the Commission on January 14, 1999, and the authorized assignment was consummated on March 11, 1999.

As documented with the attached ownership reports and certificates of no change for NABCo, Matthew Mnich, as officer and director of NABCo, has been an attributable party to NABCo since at least 1996. See attached Annual Ownership Report for 1996; Certificates of No Change dated May 14, 1997, and November 6, 1998. Matthew Mnich likewise was reported as an attributable officer and director of NABCo on the ownership report filed in April 1999, following the acquisition of WJKR (then WEGE, Westerville). See attached Ownership Report (April 1999).

Consequently, Transferee Matthew Mnich, with his pre-existing interest in Licensee NABCo, has had his qualifications to be an attributable party to NABCo passed upon by the Commission via its grant of FCC Form 314, File No. BALH-19981119GR.


