### NOTICE OF A NEW BROADCAST PATTERN AND LOCATION FOR WJSJ-CD

THIS LETTER CONCERNS TELEMETRY OPERATION. THE RESPONSIBLE PARTY FOR OVERSEEING AND/OR MAINTAINING CLINICAL OR BIOMEDICAL ENGINEERING EQUIPMENT AT THIS FACILITY MUST RECEIVE THIS LETTER.

Dear Administrator or Biomedical Engineer,

WJSJ-CD has retained RF Notifications, a broadcast TV consultant, to notify you of changes to the Station's digital television channel in your area.

We are notifying you of this new transmitter location and new coverage pattern because patients at your facility may use biomedical telemetry devices that operate in the television broadcast band and may be affected when this change takes place.

On December 20, 2021, WJSJ-CD will commence broadcasting from its new location on UHF channel 28.

Certain biomedical telemetry devices have been allowed to use unoccupied TV channels in their area on a **secondary basis**, according to the rules of the Federal Communications Commission (codified at 47 CFR 15.242 (a)(1)). If interference to or from these devices arises with regard to the TV broadcast service, the devices must cease operation on that channel. It is the responsibility of the medical facility or operator of the device to identify and retune its equipment to an alternative non-interfering channel.

The contact information for the broadcast executive in charge of the TV station, along with the commencement date, TV channel and frequency band for each station are listed on the attached page(s). Please contact the individual listed on the attached page who is associated with the specific channel, if you wish for more information or want to report anticipated or actual interference problems.


