

WRJK-LD, Arlington Heights, IL, Facility ID# 68061  
Request for Extension of Construction Permit  
Section 73.3598(b) Tolling and Extension of Permit Request

Chicago 22, LLC (“Chicago 22”), permittee of low power television station WRJK-LD, Arlington Heights, Illinois, Facility ID# 68061 (“WRJK”), hereby requests a 180-day extension of time to complete construction of the digital facility authorized by very recently granted FCC Permit No. 0000054928 (“Permit”). For many years, up to and including today, Chicago 22 has been airing diverse programming over WRJK, currently through 9 multicast streams on digital Channel 11. That WRJK programming now includes: Diya TV, the United States’ only South Asian- and Indian American-focused programming; First Nations Experience, the United States’ only programming designed to serve the Native American community; WISHnet, an African American-owned multicast that provides news focused on nearby Indiana communities; LocalNow, a second African-American-owned, news-oriented multicast; as well as other streams. Chicago 22 hereby requests an extension of time to complete the construction authorized by the Permit to ensure that it can continue to provide its ongoing programming serving the public interest to viewers in one of the largest markets in the United States.

Chicago 22 has long been diligently working to convert WRJK to a digital facility. The record shows that over time WRJK has endured a series of channel displacements in the market, resulting in moves from analog Channel 22, to digital Channel 24 (CDBS File No. BLTT-19991020AAO), to digital Channel 11 (CDBS File No. BLTT-19991020AAO), and most recently to digital Channel 36 (CDBS File No. BDISDTL-20120321ACG).<sup>1</sup> In a particularly congested spectrum market, Chicago 22 has been forced to adapt to multiple spectrum landscape shifts, which made finding a permanent home for WRJK a difficult endeavor. Nevertheless, Chicago 22 has been persistent in its efforts to serve the Chicago area, as demonstrated by its most recent Displacement Application, to Channel 36, made necessary after permanent use of Channel 11 was compromised by a full power station’s post-repack facilities maximization. Earlier this week, on January 4, 2021, the Commission granted the Permit, a necessary modification allowing Chicago 22 to build its Channel 36 facilities at a new location, on the Hancock Tower in Chicago. The new Permit, however, carries an expiration date of January 10, 2022, giving Channel 22 less than one week to construct the facility at the Hancock location. Due to circumstances beyond its control, however, Chicago 22 will be unable to complete

construction prior to this imminent January 10, 2022 deadline. As shown below, Chicago 22 has been working, and will continue to work diligently to construct the Hancock facilities and remain on air.

First, in anticipation of the Channel 36 Displacement Application being granted, Chicago 22 has ordered equipment to ensure that it could timely and efficiently begin broadcasting on its new channel once it received approval.<sup>2</sup> As demonstrated in Attachment 1 hereto, Chicago 22 ordered a new transmitter for WRJK from GatesAir in October, which is currently scheduled to be shipped on January 31, 2022.<sup>3</sup>

Similarly, as demonstrated in Attachment 2 hereto, Chicago 22 has also ordered from Jampro Antennas, Inc. (“Jampro”) a new custom antenna for WRJK, which it appears Jampro will not be able to deliver until sometime in June or even July. After working closely with its consulting engineer, Chicago 22 concluded that it could meet FCC technical requirements by using such a highly customized antenna from the Hancock Tower location. Jampro turned out to be the only vendor in position to design and manufacture this antenna. Chicago 22 consequently ordered it in anticipation of the Permit being granted. Jampro has since advised that they do not expect to be able to deliver the antenna until June or July of this year due to supply chain shortages and pandemic-related staffing shortages.<sup>4</sup>

Second, again in anticipation of the Permit’s grant, Chicago 22 has been actively negotiating a lease with rooftop manager American Tower for WRJK on Hancock Tower. The parties’ diligent efforts in this regard have brought them close to final agreement on lease terms. The availability of this site will substantially facilitate Chicago 22’s ability, upon delivery of the ordered equipment, to install that equipment promptly and begin broadcasting on Channel 36.

Grant of the extension requested herein would amply serve the public interest by allowing WRJK to take the steps necessary to *continue* to provide multiple, unique channels of programming that demonstrably serve the needs and interests of the diverse viewing audience resident in one of this country’s largest and most diverse markets.

This request is strongly supported by the fact that Chicago 22 has worked diligently in its efforts to timely construct the facility (e.g., equipment orders and productive lease negotiation), yet circumstances beyond its control have made construction by January 10, 2022 impossible.

As noted above, with the Permit’s grant this week, Chicago 22 has had less than a week to construct its facilities at an entirely new location. Furthermore, supply chain and pandemic-related delays are causing significant delays in delivery times for equipment that is necessary to

construct the facility. Faced with an imminent January deadline without a definite date for delivery of equipment, Chicago 22 must request an extension. Provided there are no additional, unanticipated delays, particularly with respect to the highly customized Jampro antenna, Chicago 22 expects to be able to construct the facility by July 10, 2022. Chicago 22 therefore respectfully requests an extension of the Permit's term to July 10, 2022.
