

## **Renewal of License – TV Translator/LPTV Certifications, Discontinued Operations Narrative**

DTV America Corporation acquired WQDH-LD, Wilmington, NC, Facility: 182080 upon filing a Notice of Consummation on 8/26/2015, FCC File Number: BALDTL-20141024ABH. At the time of Consummation, the station was operational pursuant to a License to Cover, FCC File Number: BLDTL-20150113AAA, granted on 1/23/2015.

In addition to the periods of silence noted in the Adherence to Minimum Operating Schedule Narrative,<sup>1</sup> the station went silent on 8/14/2018 and filed a Silent STA request, FCC File Number: 0000058979, on 8/17/2018, which was granted on 8/17/2018. The reason for the period of silence was that the station was undertaking efforts to construct its permanent broadcast facility pursuant to the granted Displacement application, FCC File Number: 0000052705. Additionally, DTV America Corporation was operating in a resource-constrained environment due to the 600 MHz Incentive Auction repacking process. Station owners, particularly LPTV station owners which were deemed lower priority, that were seeking to build new broadcast facilities had access to far fewer resources such as tower crews and equipment than they would have had otherwise, a factor that the Commission and the Media Bureau acknowledged.<sup>2</sup>

The station filed a Silent STA extension request on 2/12/2019, FCC File Number: 0000067858, while it continued its efforts to construct its permanent displaced broadcast facility. The Licensee added new team members to facilitate the planning, design and construction of new facilities and diligently prepared site summaries and sketches, whilst completing the engineering design process and evaluating its Internet options for content delivery. The station was in contact with transmitter manufacturers and collecting quotes from vendors to complete construction.

The station duly filed a Section 312(g) waiver request on 8/14/2019, FCC File Number: 0000067858, as amended, which was granted by letter decision dated March 23, 2020.<sup>3</sup> In the letter decision, Commission staff noted, “Consistent with the public interest and prior Bureau actions, we will provide section 312(g) relief to displaced LPTV and TV translator stations that were displaced by the Incentive Auction and pursued new displacement channels.”

The station resumed operations when it filed a License to Cover application, FCC File Number: 0000083869, on 10/3/2019, which was granted on 10/17/2019. Since that date, the station has been operating pursuant to its authorized specifications except as otherwise noted herein.
