

Articles of Incorporation, Two Harbors Community Radio

The undersigned incorporators are individuals 18 years of age or older and adopt the following articles of incorporation to form a nonprofit corporation (Chapter 317A)

ARTICLE I NAME

The name of this corporation shall be Two Harbors Community Radio.

ARTICLE II Registered office address

The place in Minnesota where the principal office of the corporation is to be:

ARTICLE III PURPOSE

This corporation is organized exclusively for educational purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Two Harbors Community Radio provides low power listener-supported radio to build community in the greater Two Harbors area through intergenerational grassroots participation. Two Harbors Community Radio offers an open forum for all voices to be heard in an atmosphere of respectful inquiry into our shared social issues and respective cultural expressions and beliefs.

Two Harbors Community Radio services include:

- local news, community announcements and emergency management information;
- a medium for local creative arts expression and coverage of community and school events;
- a forum for exchange of information, opinions and ideas;
- information for visitors to our area to enhance their experience on the North Shore; and
- opportunities for multi-generational listener participation in all aspects of community radio.

ARTICLE IV EXEMPTION REQUIREMENTS

At all times the following shall operate as conditions restricting the operations and activities of the corporation:

1. No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth in the purpose clause hereof.
2. No substantial part of the activities of the corporation shall constitute the carrying on of propaganda or otherwise attempting to influence legislation, or any initiative or referendum before the public, and the corporation shall not participate in, or intervene in (including by publication or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.
3. Notwithstanding any other provisions of this document, the organization shall not carry on any other activities not permitted to be carried on by an organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or corresponding section of any future tax

code, or by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future tax code.

ARTICLE V MEMBERSHIP/BOARD OF DIRECTORS

This corporation shall have members. The eligibility, rights and obligations of the members will be determined by the organization's bylaws. The management of the affairs of the corporation shall be vested in a board of directors, as defined by the corporation's bylaws. No director shall have any right, title, or interest in or to any property of the corporation. The number of directors constituting the initial board of directors is seven; their names and addresses are as follows:

Members of the initial board of directors shall serve until the first annual meeting or other time as specified in the bylaws, at which their successors will be duly appointed and/or elected and qualified, or removed, as provided in the bylaws.

ARTICLE VI PERSONAL LIABILITY


No member, officer, or director of this corporation shall be personally liable for the debts or obligations of this corporation of any nature whatsoever, nor shall any of the property of the members, officers, or directors be subject to the payment of the debts or obligations of this corporation.

ARTICLE VII DURATION /DISSOLUTION


The duration of the corporate existence shall be perpetual until dissolution. Upon the dissolution of the organization, assets of the corporation shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

ARTICLE VIII INCORPORATION


