

DESCRIPTION OF PRO FORMA TRANSFER OF CONTROL

This application is one of 19 applications filed concurrently seeking the Commission's consent, *nunc pro tunc*, to the *pro forma* transfers of control of the licensee entities listed below (the "Licensees"), all of which are indirectly controlled 100% by Byron Allen Folks.¹

Each of the Licensees is controlled 100% by Byron Allen Folks through a series of wholly owned intermediate holding companies (collectively, "Allen Media").² The attached diagram depicts the current organizational structure of Allen Media. Each entity shown on the diagram is 100% wholly owned by the entity/party immediately above it. In July 2021, for business organizational purposes, Allen Media inserted a new wholly-owned limited liability company – Allen Media Holdings II, LLC – into the vertical ownership structure between Mr. Folks and Allen Media Holdings, LLC, of which Mr. Folks was previously the 100% direct owner. Mr. Folks is the sole member of Allen Media Holdings II, LLC. As shown in the attached diagram, each of the Licensees remain under the 100% control of Mr. Folks. Aside from Allen Media Holdings II, LLC, all of the other wholly owned entities in the Allen Media vertical ownership structure have been previously approved by the FCC.³

In preparing biennial ownership reports for the Licensees, Allen Media realized that it had inadvertently overlooked the need to file applications covering the *pro forma* transfer of control resulting from the

insertion of Allen Media Holdings II, LLC into the ownership chain of the Licensees. Accordingly, Allen Media respectfully requests that the Commission grant its consent, *nunc pro tunc*, to the *pro forma* transfer of control described herein. As the Licensees remain under the 100% control of Mr. Folks, use of a Form 2100, Schedule 316 is appropriate.

The officers, directors, and attributable interest holders of each of the Licensees are set forth in the Licensees' recently filed biennial ownership reports.⁴ The officers of Allen Media Holdings II, LLC are as follows:
