MINOR MODIFICATION OF CP  
KONK(FM), ATLANTIC CITY, WYOMING, CH. 298C1  
MICHAEL RADIO COMPANY, LLC  
APRIL 2022

This Technical Statement is made in support of a minor change of Construction Permit (“CP”) application being filed by Michael Radio Company, LLC (“MRC”) for KONK(FM), file number 0000159323, at Atlantic City, Wyoming, Channel 298C1.

This modification of CP is being made to simply correct the tower site coordinates by one second in Longitude. The original Longitude seconds are being changed from 46.8 to 45.8. This was a typographical error. No other changes in antenna heights or power are being proposed. This will not have any material impact from the original application or the CP since the change in distance is only 0.02 kilometers.

Figure 1 shows a channel spacing study conducted from the proposed transmitter site of N. 42°- 34’- 42.4”, W 108°- 42’- 45.8” for channel 298C1.

Figure 2 is the predicted 70 dBμ city grade service contour for the proposed operation of KONK(FM). It shows the contour will completely encompass the entire community of Atlantic City without terrain obstruction.

It was determined that the proposed operation of KONK(FM)(CP) at Atlantic City, Wyoming on channel 298C1 from its proposed transmitter will meet all of the requirements for a commercial FM broadcast station under the current technical rules of the commission.
