

PARTIES TO THE APPLICATION

In the instant and eleven related applications, the parties seek the Commission’s consent to the assignment of the licenses of 13 full-power television broadcast stations from subsidiaries of CMG Media Corporation (f/k/a Terrier Media Buyer, Inc. and d/b/a Cox Media Group) to subsidiaries of Imagicomm Communications, LLC (“Imagicomm”).
