Multiple Ownership

Applicant, Xavier Entertainment, LLC (“Xavier Entertainment”), hereby certifies that it is in compliance with the Commission’s multiple ownership rules pursuant to 47 C.F.R. § 73.3555(a) with respect to the proposed modification of FM broadcast station KOTX, Channel 254C3, Hebbronville, Texas.

Xavier Entertainment was the winning bidder in Auction 109 for the following FM broadcast stations:

MM-FM1249-A, San Isidro, Texas

MM-FM1107A, Carrizo Springs, Texas

Xavier Entertainment is also currently a party to a Local Marketing Agreement, dated April 12, 2021, by and between MBM Texas Valley LLC (“MBM”) and Xavier Entertainment, with respect to FM broadcast station KZSP, South Padre Island, Texas (Facility ID No. 56473) (“KZSP”). MBM is the current licensee of KZSP. On April 14, 2021, however, an application to assign KZSP’s license to Xavier Entertainment was filed with the Commission (*See* LMS File No. 0000143402). Accordingly, Xavier Entertainment is the proposed assignee of KZSP as that application remains pending.

As demonstrated by the map attached hereto, the proposed contour of KOTX does not overlap the proposed contour of MM-FM1249-A, San Isidro, Texas or MM-FM1107A, Carrizo Springs, Texas. Moreover, the proposed contour of KOTX does not overlap the contour of KZSP. Accordingly, KOTX, Hebbronville, Texas is not in the same market of any station in which Xavier Entertainment has a current or proposed attributable interest.

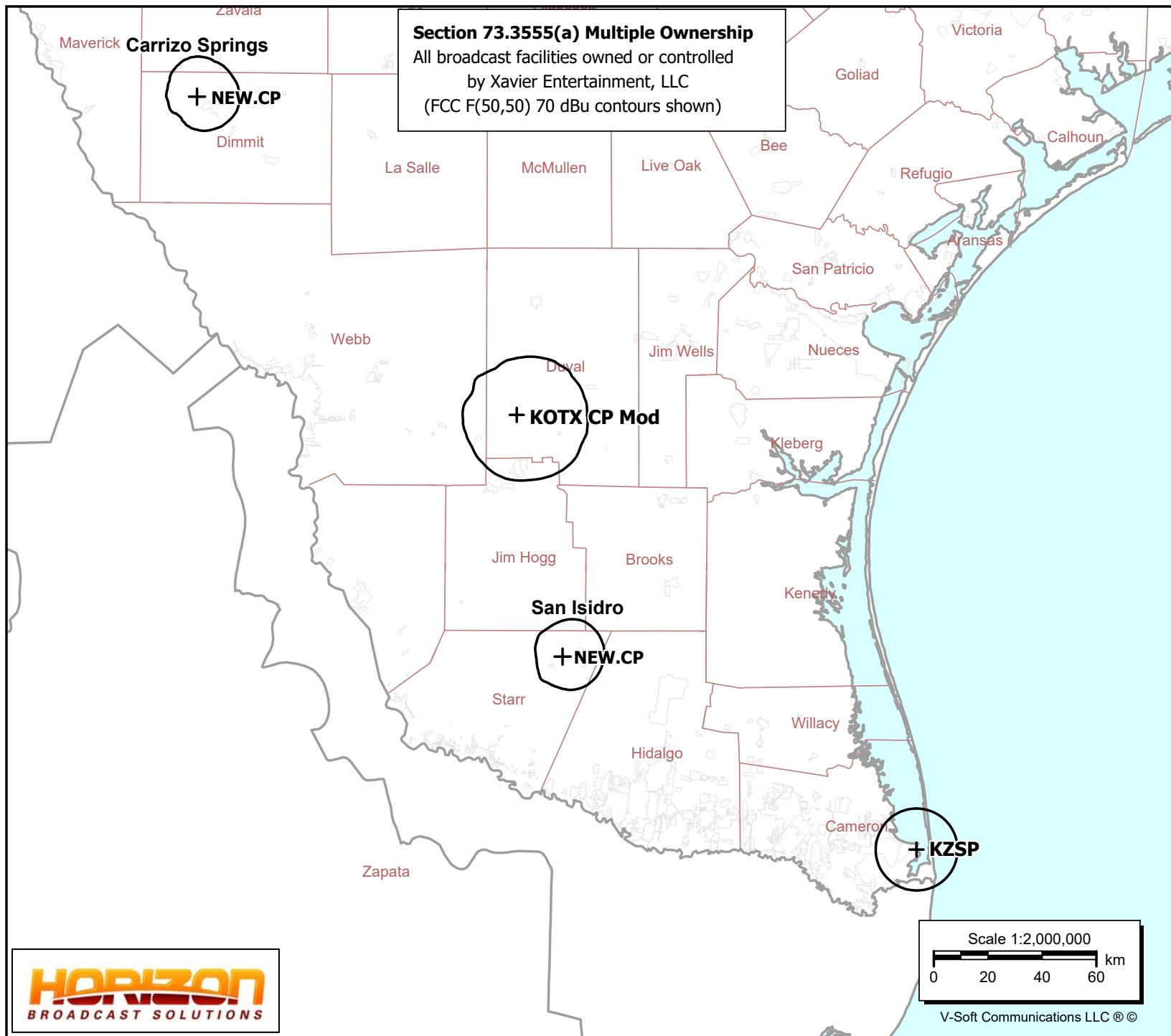
Therefore, Xavier Entertainment is currently and will remain in compliance with the Commission’s multiple ownership rules.
