

**Central Dakota Enterprises, Inc.**  
**Application for Assignment of License**

**EDUCATIONAL OBJECTIVE**

Central Dakota Enterprises, Inc. ("CDE") is a not-for-profit corporation organized in 1977 under the laws of the State of North Dakota. As set forth in its Articles of Incorporation (attached hereto), the purposes of CDE are to engage in, foster, encourage, promote, and propagate evangelical churches and missions, and Christian and charitable interests, including establishment, maintenance, and operation of orphanages, homes for juveniles and others, hospitals and schools, and Christian mission work in North Dakota and throughout the world. In so doing, CDE utilizes printing, mailing, radio, and the spoken word so that the people of the world may hear the Gospel and accept Christ as their own Savior.

As indicated in this application, CDE presently is the licensee of FM station KNDR(FM), Mandan, North Dakota (Facility No. 9869). CDE operates KNDR with limited commercial time. Consistent with the purposes set forth in CDE's Articles of Incorporation, approximately 75 percent of KNDR's daily broadcasting schedule consists of music in the Christian faith, and the remaining 25 percent consists of Bible discussions and Christian faith-based talk programming. The Bible discussions and talk programming reinforce the messages contained in the Christian music. CDE has been utilizing KNDR and related resources (such as the station's website) to promote core family values and to help listeners in Mandan, ND and the surrounding areas with life skills, all in keeping with the teachings of the Bible.

CDE intends to utilize KXRP(FM), Bismarck, North Dakota (Facility No. 90269), the station that is the subject of this assignment of license application, in much the same manner as it utilizes KNDR. That is, following Commission approval of this application (and the consummation thereof), CDE intends for the vast majority of the programming on KXRP to consist of Christian music and the rest of the programming will focus on Bible discussions and Christian faith-based talk programming. Like the programming on KNDR, the programming on KXRP will promote core family values and will help listeners in Bismarck, ND and the surrounding areas with Christian-based life skills, consistent with the teachings of the Bible.

CDE recognizes that, unlike the manner in which it operates KNDR, no commercial announcements may be carried at all on KXRP. Instead, CDE will seek to obtain donor acknowledgements and underwriting announcements associated with the programming carried on noncommercial educational FM station KXRP, in compliance with the Communications Act of 1934, as amended, and the Commission's rules and published policies promulgated thereunder.

CDE believes that the programming on KNDR (and on KXRP) that is provided through music, interviews and public service inspires thought and positively affects its service area. CDE plans to bring its faith-based programming to KXRP to listeners in Bismarck and the surrounding areas.

For the foregoing reasons, grant of this application would serve the public interest, convenience and necessity.
