

FCC EDUCATIONAL PROGRAM EXHIBIT

The purpose of this exhibit is to demonstrate Slab City Community Group Inc's ("SCCGI's) educational objectives and that the proposed radio station will be used for the advancement of an educational program under 73.503(a) of the Rules. The rules describe that noncommercial licenses are not limited to classroom instruction, but may "transmit educational, cultural, and entertainment programs to the general public," (Section 73.503(b)) in the advancement of a radio program. The following clearly demonstrates SCCGI's eligibility:

EDUCATIONAL OBJECTIVE

PAST EDUCATIONAL PROGRAMS

SCCGI is a tax-exempt educational corporation under section 501(c)(3) of the IRS code. Within its Articles of Incorporation, it states the purpose of SCCGI.

Our purpose is "to provide education and charity for Slab City Residents by:

- allowing affordable living space to low income, moderate income, elderly, and or disabled residents of Slab City;
- address the systemic source of homelessness, locally and globally by providing education about living off the grid, (without the need to be connected to power plants), including encouraging and providing education about local ecological land stewardship, and permaculture agricultural practices;
- developing and encouraging local artistic projects;
- promoting and providing education and information about civic engagement;
- providing education and encouragement to Slab City Residents to participate in the economic redevelopment and stability in Imperial County, California.

The Slab City Community Group will operate as a Community Land Trust in order to meet its purpose, mission, goals and objectives."

SCCGI "goals and objectives are to empower Slab City Residents to:

- organize, plan for, create, sustain and participate in our unique "off the grid" community through education and practice by building a prosperous and healthy community which incorporates artistic, agricultural and environmentally sound values and principles;
- to promote and sustain artistic expression experienced at Slab City;

- to connect Slab City Residents with each other;
- allowing and encouraging affordable living space to low income, moderate income, elderly, and or disabled residents of Slab City;
- to encourage Slab City Residents to engage in economic redevelopment and stability in Imperial County.

We have over our long existence as a nonprofit organization:

- Animal Water Stations provided by a generous donation from and collaboration with S.O.A.R. (Facebook: Society's Outcasts Animal Rescue; Web: <http://www.societysoutcasts.com>).
- SCCGI was also recognized by the Imperial County Board of Supervisors in 2016 with a grant from the Imperial County Community Benefit Program for a proposed Garbage Dumpster and Portable Restroom Project.
- More recently, we collaborated with the Imperial County Department of Environmental Health staff, as part of a 2018 California Environmental Protection Agency (CalEPA) Environmental Justice Enforcement Taskforce Initiative project and CalRecycle staff in 2019 to hold a Slab City Pilot Cleanup Project that resulted in the disposal of 17.03 tons (34,060 pounds) of trash.
- Instructed many individuals on how to live off-the-grid.

PROPOSED EDUCATIONAL PROGRAM

SCCG intends to utilize the proposed facility to extend its educational mission to the airwaves by carrying:

- * Debates, independent news, and issues of concern to Slab City.
- * Off-grid programming featuring independent and grassroots voices.
- * Promote music education and independent artists on non-commercial radio.
- * Broadcast copyright-safe record libraries

The radio program will expand our current programs to help more fully actualize our original intent as described in our Articles of Incorporation.
