

**KCVB-CD Online Public Inspection File**

During the last license renewal period, the Cache Valley Broadcasting, LLC (“Licensee”), licensee of KCVB-CD, Logan, Utah (Facility ID No. 69693) (“KCVB-CD” or the “Station”), has failed to comply with certain Online Public Inspection File (“OPIF”) requirements with respect to KCVB-CD.

**Children’s Television.** Licensee inadvertently failed to timely upload to its OPIF several of its Children’s Commercial Limitations Certifications, but has since uploaded them. Licensee also inadvertently failed to timely submit its Children’s Television Reports for Q3-4 of 2017, Q1-4 of 2018, Q1-3 of 2019, and 2021. Licensee has since filed the Report for 2021, but LMS will not permit Licensee to submit information regarding the 2017, 2018, and 2019 quarterly Reports.

Licensee notes that it has produced locally multiple programs, including the *Valley Channel Game of the Week*, for many years as part of its children’s television obligations. Licensee has aired this programming in accordance with its requirements throughout its license period, though it acknowledges that it neglected to file certain of the required Reports in certain quarters. Specifically, the program runs for 3 hours and was aired at least 50 times per quarter on the Station’s main program stream throughout 2017, 2018, and 2019. The Station does not multi-cast. None of these regularly scheduled weekly runs for *Valley Channel Game of the Week* were preempted by other programming. In addition, Licensee notes that it has maintained paper records regarding compliance with these FCC requirements and has uploaded into the Station’s OPIF PDFs of the missing Children’s Television Reports for the Q3-4 2017, Q1-4 of 2018, and Q1-3 of 2019.

**Issues/Programs Lists.** Licensee inadvertently failed to upload immediately to KCVB-CD’s OPIF several of its Issues/Programs Lists during the license period. Licensee subsequently uploaded the lists to the OPIF. Licensee prepared the Issues/Programs Lists timely, even though it did not upload them timely.

**Class A Continuing Eligibility Certificates.** Licensee inadvertently failed to timely upload to its OPIF its Class A Continuing Eligibility Certificates. Licensee has since uploaded the certificates and notes that it prepared them timely, even though it did not upload them timely.

Licensee takes its obligations as a Commission licensee, and particularly, as the licensee of a Class A station, very seriously. The COVID-19 pandemic has devastated much of the broadcast business, and unfortunately, KCVB-CD was not spared. The Station lost multiple employees throughout the pandemic, which is especially difficult for a small company such as Cache Valley Broadcasting, LLC. Licensee has done everything in its power to remain in business during these difficult times, and is committed to adhering to Commission rules in the future, including with respect to its compliance filings. Accordingly, Licensee has put in place procedures to ensure that all of its required documentation is timely uploaded going forward.
