In accordance with the FM Broadcast Station Construction Permit herein referenced, issued by the Federal Communications Commission on 8 October, 2019, the following is submitted:

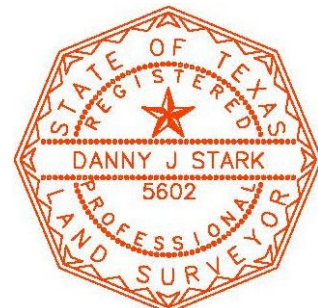
Prior to installation of the tower at this site, the entire property and surveyed and points established for tower location, three (3) guy wire tie-downs and an azimuth reference monument at 315 Degrees from tower center point.

Mr. Aaron Adams, the broadcast engineer, met the survey crew on site and provided the herein referenced optical instrument for alignment purposes.

While orienting the antenna, a Trimble Model DET-2 theodolite with a resolution of 2 arc seconds was used. The theodolite was positioned on the 315 Degree azimuth monument previously established. The theodolite was then oriented to tower centerline and vertically depressed to locate the antenna bay reference mark. A climber at the antenna bay was instructed by hand-held radio to move the antenna bay in a direction and an amount to center the antenna bay reference mark at 315 Degrees with an uncertainty of  $\pm 2$  arc minutes.

On-site measurements indicate that the antenna center of radiation is located at 734 feet (+2/-4 feet) above ground level on the 750 foot tower.

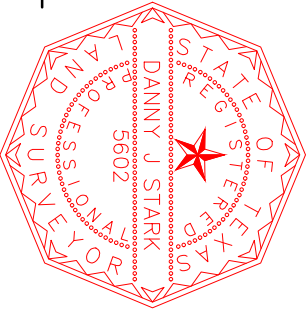

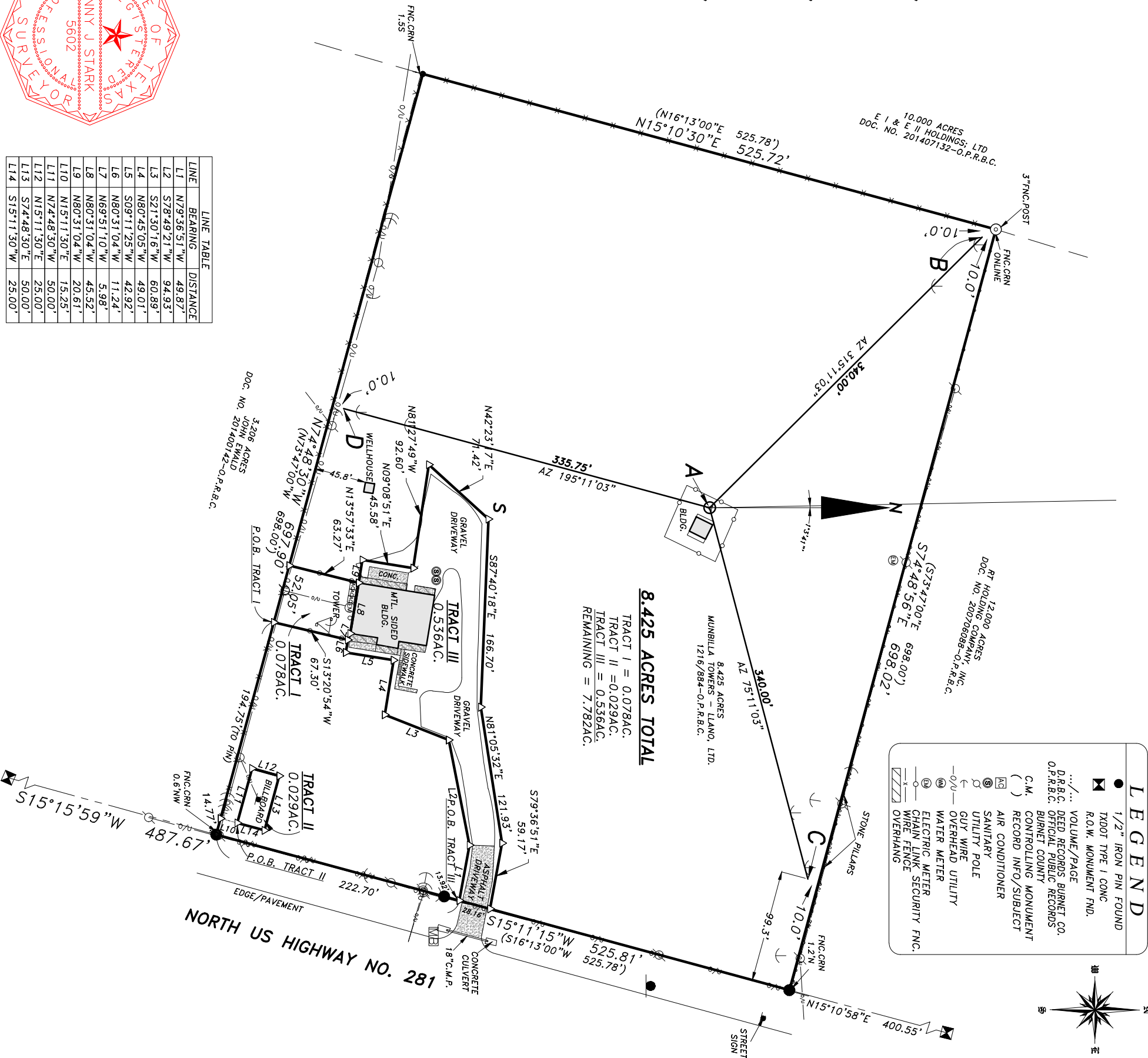

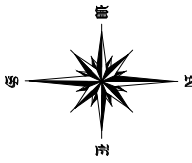
