## SECOND DECLARATION OF MARK D. PIPPIN

I, Mark D. Pippin, hereby affirm, under penalty of perjury, the following.

1. I am the overall Construction and Project Manager for the improvement of the licensed main facilities of Radio Station KHSB-FM that Construction Permit BPH-20190322AB (the *CP*) has authorized.
2. I have been on-site for the erection of the broadcast tower covered by Antenna Structure Registration No. 1312267 (the *Tower*), and for the installation of the Station's new main antenna, PSI Model PSIFMR-3E-R-DA (the *Antenna*).
3. Prior to the Antenna's installation, I personally inspected the Antenna, its shipping crate, its accessories, and the manufacturer's instructions. I found the Antenna and its accessories to be correct and undamaged from shipping.
4. I conferred with the construction crew about the installation, and had all personnel involved review the installation instructions prior to the actual installation. I was present at all times while the Antenna was being installed.
5. I supervised the initial orientation of the Antenna to ensure that it coincided with PSI's specifications. After its initial installation, the Antenna proved to be oriented correctly at 315 degrees true as per PSI's specifications.
6. I arranged for Cuplin and Associates, Inc. (*Cuplin*), a surveying firm based in Marble Falls, Texas, to supply a surveyor licensed by the State of Texas to survey the antenna orientation of the Antenna and of the Tower. Danny J. Stark of

Cuplin conducted the survey on February 11, 2022. I was present for the survey. As Mr. Stark affirms in his Survey Report, dated March 14, 2022, which forms Exhibit 6 to the above-specified License Application, the Antenna was installed in accordance with the CP's parameters and with PSI's installation instructions.

7. I hereby ratify Mr. Stark's Survey Report.
