

STATEMENT SUPPORTING APPLICATION TO AUTHORIZE A CHANGE IN LICENSE STATUS FROM COMMERCIAL TO NONCOMMERCIAL

The licensee of an AM, FM, or TV commercial station may propose to change from commercial to noncommercial educational on a modification of license application, provided that the application contains completed Sections II and IV of FCC Form 340. Bible Broadcasting Network, Inc., ("BBN") is the proposed assignee of the license of WHHH(FM), Indianapolis, Indiana. BBN proposes to change the status of WHHH to noncommercial educational ("NCE") since WHHH operates on Channel 275 (which is between Channels 221 to 300 on a channel not reserved for NCE use), via this modification of license application.

This application is contingent on the grant of a simultaneously-filed application for consent to assignment of license of WHHH to BBN. A copy of the assignor's¹ permission to file this contingent application is attached elsewhere in this application.

Also attached hereto is completed Section II of FCC Form 340 establishing BBN's qualifications as an eligible noncommercial educational licensee. Since this is not an application for a new authorization, Section IV is not applicable.
