The applicant certifies that the station will be used for the advance of educational programs will further that objective in accordance with 47 CFR § 73.503.

KFAITH Incorporated is a 501(c)(3) organization with seeks to provide programming for its community of license. KORB will be an independent, noncommercial station that serves, engages with, and connects to local community and visitors to the region through diverse music, information, and cultural contents. A weekly public interest show that specifically addresses the needs of Hopland, CA, and the communities covered by KORB and its translators will strive to provide our underserved, rural community with alternative programming to the other broadcast media within the listening area. KORB will provide volunteer opportunities for community members and ongoing support for the area's nonprofit organizations, houses of worship, and diverse community members. KORB will enrich and unify the community through entertainment, interviewers, community involvement, and local church services.

Educational Objective: KFAITH proposes to use the station to educate its listening audience through Biblical teaching, entertaining programming, music with a positive message, educational programming, and informative noncommercial programming. The type of educational programming will include:

- 1) Biblical teaching
- 2) Programming on Family Issues
- 3) Money Management
- 4) Philosophical Problems
- 5) Opportunities Facing Children and Young Adults
- 6) Information Concerning the Scope and Availability of other non-profit services in the Community

Programming for KORB will be designed to provide listeners with educational opportunities, with a particular emphasis for the youth of the community. Programming will include inspirational music selections and commentaries and other music forms deemed appropriate. The station will also provide public service publicity for organizations serving the community, local weather information and announcements concerning emergency situations in the broadcast area.
