

Discussion

The firm of Munn-Reese has been retained to prepare this Gain/Loss study for the instant KCHF-DT minor change application. The present location of the station is at a mountain site that is often inaccessible during winter months. In the event of transmitter trouble or commercial power failure it is not always possible for maintenance personnel to safely reach the transmitter site. In the event of a commercial power failure the station can only operate until the standby generator depletes its fuel supply because the fuel trucks are also unable to reach the site in bad weather. The proposed site is shared with numerous other radio services including other broadcasters. And although it is also a mountain site it does remain accessible during winter weather.

The proposed site also offers improved line-of-sight service into the greater Santa Fe area. Other facilities that were either authorized or operating from the vicinity of the present licensed site have already relocated to the vicinity of the proposed site.

The attached KCHF-DT Gain and Loss Areas map shows the present licensed contour and the contour proposed in the instant application. The respective gain and loss areas are labeled in this exhibit.

Other services entering the KCHF-DT licensed and proposed contours are shown in the other attached map which was prepared with the V-Soft Probe 4 software using a currently updated database of stations. The software was used to color code the number of services available.

The attached Gain/Loss Population Report tabulates the population that will have five or fewer services available in the gain and loss areas. Further details are provided in the Tabulation of Services within the Licensed KCHF-DT Contour and the Tabulation of Services within the Proposed KCHF-DT Contour. The loss area does include 6306 people who will no longer receive service from a full-service facility and 1464 people who will only receive one full-service facility. Many of these people will be able to receive service from one or more LPTV facilities. Because of the rural nature of the area, many people also receive service from satellite providers.





