Maryland Estate Tax Return Federal Estate Tax Return Fiduciary Tax Return

*** Copy of Order of Payment (Estates & Trusts § 8 105) which is applicable if the assets of the estate are insufficient to pay all claims in full was provided to the Personal Representative

*** Personal Representative commission is income and may be subject to income tax

*** If the estate has any firearms ammunition or destructive devices you must consult with an attorney to ensure compliance with all federal state and local laws All estate assets must be reported on the Inventory

*** If the due date falls on a Saturday Sunday holiday or other day the Register of Wills Office is closed the document must be filed by the close of the next business day (Maryland Rule 1 203(a))
