TERMS OF ASSIGNMENT

This assignment is a voluntary transfer of the license to the proposed assignee without any consideration or remuneration. There is no Asset Purchase Agreement or other formal agreement associated with this transaction.

COMPARATIVE REVIEW – POINT SYSTEM

The original construction permit application (BNPL-20131113BIO) was granted as part of a three-way involuntary time share between 1MIAMI, Tabernacle of Glory Community Center (Glory) and Actions for a Better Future, Inc. (Actions). Following the grant, Tabernacle's original construction permit (BNPL-20131106ALS, as modified by BMPL-20150416AAY) was never constructed resulting a permit cancellation on October 16, 2016. Actions would license their facility (BLL-20170626AAB) and entered into a voluntary time share agreement with 1MIAMI. The license for Actions would eventually be cancelled and its call sign deleted on February 4, 2020 thus making 1MIAMI the sole remaining member of 2013 LPFM MX Group # 105.

1MIAMI completed their construction and were granted a license (BLL-20170512AAB) on May 26, 2017. 1MIAMI has not had any silent periods since being originally licensed. Since more than four years of licensed operation has passed, the assignment of this license is authorized pursuant to §73.865 of the Commission's Rules.
