EDUCATIONAL STATEMENT OF PROPOSED ASSIGNEE

The specific objectives and purposes of KVHH-LP and Christian Voice Ministries Inc. shall be to educate, entertain and create community among fellow believers in Jesus Christ. We plan to advance the educational objectives of this organization by doing the following.

1. Program educational programs and contemporary Christian Music to the general population via KVHH-LP radio station and via internet streaming available on the radio station's website. This will both educate and entertain our current listeners.
2. Record and play over the air, local church services. This will act as a service to both educate and inform the general population of the different programs and diversity of teachings available at local churches.
3. We will broadcast an hourly news cast to educate the public to worldwide news events on an "up-to-the-minute" basis.
4. Offer airtime to local and national Christian artists to feature their original musical compositions and teachings. This would greatly increase the awareness of their materials to both our local and streaming audiences.
5. Help local businesses and organizations by informing the public of the services they offer to the community.
6. Help local organizations by informing the public of their upcoming events in the form of on-air recorded announcements.
7. Offer airtime to additional churches and nonprofits to be run within our Sunday morning local worship section.

8. Pastors at local churches have offered to provide us with recordings of their teachings. These will be edited and broadcast at specific times to act as an additional educational out-reach to our community and worldwide via internet streaming.
9. We will produce a local “community calendar” of events featuring local organizations and schools giving them a “voice” to the community that they would not normally have.
