Re: Construction Permit Expirations and  
License Application

Dear Former Permittee:

This is with respect to the expired digital lower power television (LPTV) construction permits listed in the attached Appendix. Commission records indicate that the construction permits for the facilities expired prior to the filing of an application for license to cover. While an application for license to cover was initially submitted for six of the stations,<sup>1</sup> those applications were subsequently withdrawn. The requests for withdrawal stated that “[i]nformation has been discovered by the proposed licensee that indicates that contrary to what previously had been believed, the facility was not timely constructed by the required deadline date. Therefore, this application is being dismissed.”<sup>2</sup> As a result, it appears that construction of the stations was not completed prior to expiration of their construction permits. Furthermore, in the case of K20OI-D, Kirksville, Missouri, a license to cover was filed on May 17, 2022, nearly a month after the Station’s construction permit expired on April 21, 2022.

Section 74.788(b) of the Commission’s rules states that:

Any construction permit for which construction has not been completed and for which an application for license or extension of time has not been filed, shall be automatically forfeited upon expiration without any further affirmative cancellation by the Commission.<sup>3</sup>

As such, the construction permits have been automatically forfeited.

Accordingly, pursuant to section 74.788(b) of the Commission’s rules,<sup>4</sup> the construction permits for the stations referenced in the attached Appendix were **AUTOMATICALLY FORFEITED** and the call signs have been **DELETED**.<sup>5</sup> In addition, the application for license to

cover (LMS File No. 0000190774) for LPTV station K20OI-D, Kirksville, Missouri, **IS DISMISSED**. All authority to construct or operate the stations has been **TERMINATED**.<sup>6</sup>
