Thank you so much for your response. We would be happy to submit this filing in LMS; however, any additional information you can provide regarding the type of filing that should be used would be greatly appreciated. 47 C.F.R. § 73.1680 specifically requires an “informal letter” to be sent to the Commission; however, there does not appear to be a filing type in LMS that fits with this description. Should the filing be in the form of an STA? This station has an active STA authorizing its operation with reduced power, and there is no option to amend or update that STA in LMS. Please let us know if a new STA is required or if another filing type would be preferable to comply with the notification requirements for emergency antenna use in this case. Thank you so much, and please let us know if any additional information is needed.
