

**Certification Regarding Compliance with
Section 73.3526 of the FCC's Rules During the Preceding License Term**

Upon review of its Public Inspection File to determine whether documentation required by Section 73.3526 of the FCC's Rules has been uploaded when required,¹ Applicant found that:

- Some documents were not added to the station's 73.3613 list (or, alternatively, uploaded) within 30 days after execution. Applicant included an updated Section 73.3613 list with its most recent biennial ownership report, and Applicant has uploaded a supplemental list to its Public Inspection File to account for relevant documents executed since then and not already listed in the ownership report.
- The Quarterly Issues & Programs List ("QIP") for Third Quarter 2016, due on October 11, 2016, was uploaded on October 19, 2016.
- The QIP for Fourth Quarter 2016, due on January 10, 2017, was uploaded on January 19, 2017.
- The QIP for Second Quarter 2017, due on July 10, 2017, was uploaded on July 13, 2017.
- The QIP for Third Quarter 2017, due on October 10, 2017, was uploaded on October 16, 2017.
- The QIP for Second Quarter 2018, due on July 10, 2018, was uploaded on July 19, 2018.
- The QIP for Third Quarter 2018, due on October 10, 2018, was uploaded on April 9, 2019.
- The QIP for Third Quarter 2019, due on October 10, 2019, was uploaded on October 11, 2019.
- The QIP for Fourth Quarter 2019, due on January 10, 2020, was uploaded on January 14, 2020.
- The Commercial Limits Certification for Third Quarter 2016, due on October 11, 2016, was uploaded on December 9, 2016.
- The Commercial Limits Certification for Fourth Quarter 2016, due on January 10, 2017, was uploaded on January 20, 2017.
- The Commercial Limits Certification for Third Quarter 2017, due on October 10, 2017, was uploaded on October 11, 2017.
- The Commercial Limits Certification for Fourth Quarter 2017, due on January 10, 2018, was uploaded on January 12, 2018.

Applicant will continue to remind station staff of Public Inspection File requirements and upcoming deadlines, will provide additional training to station staff, and will work to implement more robust accountability procedures to enhance the station's compliance with Public Inspection File deadlines going forward.

¹ Applicant notes that the deadlines to file or upload certain documents, including the 2017 Biennial Ownership Report and the various Fourth Quarter 2018 certifications and reports, were extended due to government closures. *See* 47 C.F.R. § 1.4; *see also Revisions to Filing and Other Deadlines Following Resumption of Normal Operations*, Public Notice, DA 19-26 (rel.
