Response to Letter of Feb 3, 2023

Dear Sir/Madam,

This letter is in response to the letter concerning Silent Status for WNAP-LP.
The attached information is to support and provide evidence of the operation.

As the Technical Consultant for the station I have submitted paperwork relative to the Construction of the Licensed Facility. I am Legally Blind. I am in End Stage Renal Failure and beginning kidney dialysis. If there are any submission Issues I want to assist in resolving them. I certify my work in this response at the end of this letter. All work I do is done through both CCTV and blind assistive devices. I have had others help in the production of these documents.

WNAP was constructed per the Construction Permit. The facility Requested Silent Status August 7, 2021. A License To Cover the Application was Granted 11/10/2021 at which time the facility began operation under Program Test Authority with .100 Watts ERP. Except for brief power outages and

equipment maintenance the facility has been in operation continuously since this time.

A Letter was sent to Staff in October of 2021 to make sure Staff knew the station was in fact operational and to correct the recods showing the station is in Florida, which it is not. This letter has been scanned and is provided. There was a second letter sent as well. There has not been any response to these letters. One letter is attached in Reply.

Facility

The station utlizes a BKG-88 FM Antenna with has a minus 3db gain. The transmitter is an Elettronica Solid State FM Transmitter capable of 300 watts. Per the License application the facility is at 40° 11' 20.4" N+ 085° 23' 44.3" W-. The structure is 36.6 meters and the height of the antenna is 30 meters. The antenna transmission line is 20.6 meters and the Anteena Loss is minus 3db with cable loss at 1.3db. The transmnitter requires 269 watts to produce 99.94 Watts ERP.

Operation

WNAP-LP has no paid staff, however, we are providing a current Staff Lineup which has remained largely the same. There are no W-2 or 1099 forms for our Volunteers.

Jackson Park Baptist Church Inc has no checking account and operates with Volunteer Staff and utilizes facilities of another Church for infrastructure. Individual Volunteers, including myself, may furnish broadvast materials such as CD's or other material which we are not reimbursed for.

There is no accounting software as the station operates with Volunteers and utilizes equipment donated. Unlike Commercial Radio which has a large overhead and Commercials we are a very simple operation without the trappings of Commercial Radio. We are providing all material available to show responsiveness.

There are no emails as there is no station specific email address. Emails to individual volunteers go to their personal email address and are not retained. We find some letters during the period and are providing them. Many may not have dates and are just letters thanking us. We are submitting all we currently have and will continue to look for others. We are providing a partial submission in this regard. Not having sight and having assistance locating these items has been difficult.

We are providing copies of Issues and Answers for the time period. This shows the Issues Addressed during the time period. The years 2021 and 2022 are provided. A portion of these documents cover times WNAP-LP may have been silent in 2021 between August and October.

We share power with another Church who pays the electric bills and have provided Electric Bills for the Licensed Service Address. The Church assists us with the operation. They have supplied copies of these bills showing power consumption during the time period.

On these bills Indiana Michigan Power provides a historical power usage for the entire facility including the WNAP-LP Transmitter. There is no breakdown showing the transmitter usage only.

While not all months were found back to the request date, the historical usage shows on the bills provided to Jan 2021. This is shown in kwh usage for each month.

We have Water Bills from the period. Some of the Bills show historical usage. This is evidence of use of the facility for the time period requested.

We are providing the weekly Station EAS Verification for the time period and EAS Logs during the time frame. WNAP LP is not included in the Indiana EAS plan as are many LPFM stations and Non Commercial stations. WNAP-LP utilizes a Sage Endec Encoder/Decoder.

We are providing a photo of the tower and Transmission Lines taken Feb 7, 2023. The WNAP-LP antenna is shown at 100 feet on the tower and has remained in the same place since install. The transmitter location is 900 W Powers St Muncie, IN and coordinates of the Site have been provided. Studio pictures are also provided. These facilities have remained largely unchanged since 2021.

I Certify under Penalty Of Perjury the statements herein are true and correct to the best of my knowledge and ability. As Technical Representative for the Licensee I prepared these documents with the assistance of others who have sight. I have been involved in Broadcasting for 50 years.
