Description of Transaction

The instant application is submitted to report the involuntary transfer of control of LATV Holdings, LLC (“LATV”), the indirect parent of KJLA, LLC (“KJLA”), the licensee of the following full power and low power television stations:

This involuntary change in control is the result of the death on December 31, 2022, of Mr. Walter Ulloa. Mr. Ulloa was the sole member of LATV. LATV owns 100% of the voting stock of Costa de Oro Television, Inc., which in turn is the controlling member of Costa de Oro Media, LLC, which in turn is the sole member of KJLA.

Upon Mr. Ulloa’s death, his membership shares in LATV passed to his estate, which is currently subject to a probate process. Mr. Ulloa’s widow, Alexandra Seros, is designated as the executor of his estate. At the request of the Video Division staff, KJLA is submitting this application prior to the issuance of the letters testamentary authorizing Ms. Seros to administer the estate. KJLA will amend this application once the letters testamentary are issued.

Ms. Seros, directly or through one or more trusts, also has or will have attributable interests in Entravision Holdings, LLC (“Entravision”) and KVMD License Co., LLC (“KVMD”). A list of Ms. Seros’ other broadcast interests is attached hereto as Exhibit A. These holdings comply with the Commission’s multiple ownership rules because: (1) Entravision is not the licensee of any television stations in the Los Angeles Designated Market Area; and (2) neither of the two full power television stations in which Ms. Seros has an attributable interest is rated in the top four, and ownership of two stations outside the top four is permitted under the local television ownership rule. *See* 47 C.F.R. § 73.3555(b)(1). Alternatively, because these interests were pre-existing, under Note 4 to 47 C.F.R. § 73.3555, they are not subject to divestiture.
