This radio multiple ownership analysis was prepared on behalf of WLII/WSUR License Partnership, G.P., licensee of WUKQ-FM, Mayaguez, Puerto Rico, in support of its pending application for construction permit for a minor change.\* The multiple ownership analysis was prepared according to the FCC interim contour overlap method.† Considering all attributable radio stations in the area, the following stations were analyzed:

‡ It is noted that the overlap between WKAQ-FM and WKAQ(AM) is permissible since neither of those two stations overlap a third station in the same service, which would create a third defined market for analysis. See Section 73.3555(a)(2) of the FCC Rules.

The principal community contours of the subject stations are depicted on a map included with this statement. The radio multiple ownership analysis considers only those stations with overlapping principal community contours (5 mV/m for AM stations, 3.16 mV/m for FM stations).

Radio Markets

The “radio markets” applicable to common ownership of the subject stations is defined as the area encompassed by the mutually overlapping principal community contours of the stations proposed to be commonly owned. As listed in the table below, there are two defined “radio markets” formed by the subject stations:

Count of Stations in Defined Markets

The number of radio stations in a “radio market” is determined by counting the operating stations that have principal community contours that intersect the principal community contours that define the radio market. Only those stations located within 92 km of the perimeter of the mutual overlap area of the defined market area are to be employed in the count of stations. Commonly owned stations, other than those that form the market in question were not considered in the count of stations in the defined market. In this case, only licensed AM and FM stations with contour overlap with both Market 1 and 2 contours were counted since this is sufficient to demonstrate compliance. The results of the analysis are tabulated below:

Tabulations and maps of the radio stations identified in the defined radio markets are included with this statement.


Based on the above, it is concluded that the proposed combination of the stations to be owned complies with Section 73.3555(a) of the FCC Rules.

## PREDICTED PRINCIPAL COMMUNITY CONTOURS


