

**Amendment to Application for Involuntary Pro Forma Transfer of Control
Pursuant to the Informal Request of Commission Staff
File Number: 0000216741
WKMM-LP, Harrison, MI (FIN: 193246)**

Licensee, Country King, Inc. (FRN: 0033840356) respectfully requests the Commission grant the transfer of control from the sole officer and director, David Allen Carmine, President/Secretary/Treasurer, to the personal representative of the David Allen Carmine Estate, Jeffrey J. Klaus, as the sole officer and director of Licensee. No ownership interest in the not-for-profit corporation exists nor will such be transferred.

Good Standing with the State of Michigan

Licensee is a not-for-profit corporation in good standing in Michigan. In 2002 when the corporation was incorporated, one director was required. MCLS Ch. 450.2515, Act 162. Public Act 222 of 2008 amended the Act and required corporations to elect three directors. At that time, Mr. David Allen Carmine (Carmine), as sole director, and officer, failed to timely elect two other officers to the board. Carmine reported his non-compliance in his annual reports. See 2018 Annual Report for the Licensee to the Michigan Secretary of State, attached to the original application, noting the two other directors were "not yet elected."

Nonetheless, Country King, Inc. remains in good standing with the Michigan Secretary of State. The Certificate of Good Standing with the State of Michigan is attached here to.

Authority of the Personal Representative to Direct the Nonprofit Corporation

If because of death, resignation, or other cause, a corporation has no directors in office, an officer, a shareholder, a member of a corporation that is organized on a membership basis, a personal representative, administrator, trustee, or guardian of a shareholder or member, or other fiduciary entrusted with the same responsibility for the person or estate of a shareholder or member, may call a special meeting of shareholders or members in accordance with the articles or the bylaws to fill the vacancy. MCLS Ch. 450.2515a, Act 162.

At the time of his death, Carmine was the sole director and officer of Licensee. As such, Mr. Jeffrey J. Klaus, personal representative of the David Allen Carmine Estate, may, in accordance with Michigan statute, call a special meeting and fill the vacancy.

Continuing with the Educational Purpose of the Nonprofit Corporation


The educational purpose of the licensee stated in its' articles of incorporation remains "to educate, preserve, promote, and create appreciation for the musical art form known as "country music"." The original LPFM construction permit application (BNPL - 20131022AQB) described the nonprofit purpose as "non-profit radio broadcasting" (of said country music). Both the Articles of Incorporation and the original application for the low-power FM license are attached hereto.

Following the involuntary transfer of control to the Personal Representative of the Estate, the educational purpose of the Licensee will remain the same. The sudden change in the composition of the

board will not change the mission and purpose of the nonprofit – the education, promotion, and appreciation of country music on a LPFM station.

In efforts to administer and close Mr. Carmine's Estate and winding down the non-profit corporation, the Personal Representative intends to seek out a qualified LPFM licensee, perhaps a local church, and assign the station license to such entity.
