1. Transaction Overview

a. Description of Transaction

This application (“Application”) seeks Commission consent for the transfer of control of three AM radio stations and two FM stations and their booster stations, all licensed to communities in Puerto Rico. On May 9, 2022, HMTV DTC, LLC, a Delaware limited liability company (“HMTV DTC” or “Buyer”), Univision of Puerto Rico, Inc., a Delaware Corporation (“UPRI”) and Univision Puerto Rico Station Operating Company, a Delaware Corporation (“UPRSOC” or “Transferor,” and together with UPRI, “Seller”) (collectively with Buyer, the “Parties”), entered into a Share Purchase Agreement (the “Agreement”) by which HMTV DTC seeks to acquire 100 percent of UPRI’s capital stock (the “Proposed Transaction”).¹ UPRI is the 99.9 percent direct parent of WLII/WSUR Licensee Partnership, G.P., a California general partnership (“Licensee”),² which is the licensee of the stations identified below (“Stations”). UPRSOC owns a minority 0.1 percent interest in the Licensee.³

As a result of the Proposed Transaction, Buyer will be the direct parent of UPRI (see Post-Transaction Structure Step 1 in Attachment A). Immediately after the acquisition of UPRI from Seller, HMTV DTC will contribute the stock of UPRI through a number of internal restructuring transfers to affiliates of HMTV DTC that are commonly controlled subsidiaries

of Hemisphere Media Group, Inc., a Delaware corporation (“HMTV”). The Proposed Transaction and the internal restructuring will result in HMTV DTC’s affiliate, Intermedia Español, Inc., a Delaware corporation, (“Transferee”) acquiring 100 percent indirect ownership of Licensee (*see* Post-Transaction Structure Step 2 in Attachment A). Therefore, the Proposed Transaction will ultimately result in the transfer of control of the Stations below to HMTV, as the parent of Transferee.

b. Parties to the Transaction

i. Seller

Seller is an indirect subsidiary of TelevisaUnivision, Inc., a Delaware corporation (“TelevisaUnivision”), which owns Spanish-language broadcast stations, networks, and other multimedia properties across the United States and Latin America.⁴

ii. Buyer

Buyer and Transferee are indirect subsidiaries of HMTV, which owns and operates broadcast television stations and cable networks serving audiences in the United States and Latin America. HMTV is wholly owned directly by HWK Parent, LLC, a Delaware limited liability company (“HWK Parent”), which is wholly owned by Gato Investments LP, a Delaware limited partnership (“Gato”). Gato is controlled by its sole general partner, Gemini Latin Holdings, LLC, a Delaware limited liability company (“Gemini”). Gemini, in turn, is controlled by its sole member, Peter Kern, a U.S. citizen. Searchlight II HMT, L.P., a Delaware limited partnership (“Searchlight II HMT”), is the sole limited partner of Gato.

Searchlight II HMT is owned and controlled by entities affiliated with Searchlight Capital Partners, L.P., a Delaware limited partnership (“Searchlight”).⁵ Searchlight is a global private equity investment company, whose funds invest in companies across various sectors, including telecommunications providers and media outlets. Searchlight is ultimately controlled by its three founding partners, Eric Zinterhofer (a U.S. citizen), Erol Uzumeri (a Canadian citizen), and Oliver Haarmann (a German citizen). Searchlight’s affiliates and principals have been reviewed and approved by the Commission in connection with several other broadcast and telecommunications investments, and thus are well known to the Commission and Executive Branch agencies.

Although Searchlight receives a fee for the services it provides to the Searchlight investment funds, it has no economic or other ownership interest in them and has no decision-making authority with respect to their operations. Rather, all such authority, including the decision to make investments and to make capital calls from the limited partners of the investment funds, rests with the general partners of the funds. Although Searchlight is deemed to be an affiliate of Searchlight II HMT and the investment funds, it has no direct or indirect ownership interest in Searchlight II HMT (and will not have any such interest in HMTV), and has no authority to make any decisions on behalf of Searchlight II HMT or the investment funds. Accordingly, Searchlight is not a party to this Application.

2. Pending Application Relating to Ownership of Buyer

Subject to a separately pending transfer of control application filed on September 23, 2022, Gato and Searchlight II HMT are seeking Commission consent to the transfer of control of HMTV, and its broadcast television station licensee subsidiary, Televiscentro of Puerto Rico, LLC, from Gato to Searchlight II HMT (the “HMTV Transfer Application”).⁶ Because the transaction subject to the HMTV Transfer Application is expected to be consummated either immediately prior to or concurrently with the Proposed Transaction subject to the instant Application, the instant Application describes the ownership of Buyer and Transferee following the consummation of the proposed transfer of control of HMTV to Searchlight II HMT, and thus the proposed ultimate control of the Licensee by Searchlight II HMT.

Searchlight II HMT currently is the sole limited partner of Gato, and holds a 100 percent indirect equity interest (0 percent voting interest) in HMTV. The equity interests in Searchlight II HMT are held by investment fund vehicles, Searchlight Capital II USD AIV, L.P., a Delaware limited partnership, and Searchlight Capital II (FC) AIV II, L.P., a Delaware limited partnership, which are both ultimately controlled by Eric Zinterhofer, a U.S. citizen. Searchlight II HMT is ultimately controlled by Mr. Zinterhofer and Andrew Frey, also a U.S. citizen. Upon the consummation of the transactions described in the HMTV Transfer Application, Searchlight Capital II EXU AIV, L.P., Searchlight Capital II PV, L.P., and SC II HMT, L.P., which each hold warrants in Searchlight II HMT, will exercise their respective warrants and will be issued new limited partnership interests in Searchlight II HMT. As a result, each of these investment fund vehicles, which include affiliates that are non-U.S. citizens or formed in non-U.S. jurisdictions, will hold new attributable interests in the HMTV broadcast stations, including the radio stations subject to the instant Application.

Accordingly, Searchlight II HMT has filed a Petition for Declaratory Ruling in connection with the HMTV Transfer Application (the “Petition”).⁷

The Parties’ pre- and post-Transaction structures, including the placement of the Licensee in the HMTV chain of ownership and identification of HMTV affiliates that will have an attributable interest in the Licensee post-closing, are identified in greater detail in Attachment A.

3. Public Interest Benefits of the Proposed Transaction

The Proposed Transaction will serve the public interest, convenience, and necessity. As a leading U.S. Spanish-language media company, HMTV has served U.S. Hispanic communities with news, sports, and entertainment content across broadcast and cable television platforms. HMTV’s broadcast television station, WAPA-TV, produces local programming in Puerto Rico, including 60 hours per week of highly acclaimed local news and entertainment programming. WAPA-TV also owns and operates a multicast channel, WAPA2 Deportes, a local sports network. Through this Application, HMTV now seeks to acquire the Stations, which will allow the company to leverage its video programming and broadcasting expertise in providing audio programming to audiences in Puerto Rico. The synergies resulting from the combination of WAPA-TV and the Stations will allow HMTV to increase the scope and depth of locally focused programming and enhance community service to residents of Puerto Rico. Further, HMTV is backed by Searchlight’s significant experience as a long-term investor in the media and telecommunications sectors. Searchlight is well positioned to provide additional investment in the Stations, which could include additional investments in content, digital initiatives, and community service initiatives to the benefit of local viewers.

As discussed in more detail below, the Proposed Transaction complies with all multiple ownership rules and does not create any new radio station combinations or reduce the number of competitors in the market.⁸ As detailed in the Searchlight II HMT Petition filed in connection with the HMTV Transfer Application and included here to cover the Proposed Transaction, the foreign ownership that will be attributable to Searchlight II HMT and the Licensee would not present any national security, law enforcement, foreign policy, or trade concerns.

Therefore, the Proposed Transaction is in the public interest, and the parties urge the Commission to grant the Application expeditiously.

4. Other Attributable Interests Held by Parties to the Application

HMTV's indirect wholly owned subsidiary Televiscentro of Puerto Rico, LLC ("Televiscentro") is the licensee of the following broadcast television stations:⁹

Eric Zinterhofer and Andrew Frey, who have attributable interests in Searchlight II, HMT, and Erol Uzumeri and Oliver Haarmann, who will have attributable interests in Searchlight II HMT upon the consummation of the transactions proposed in the HMTV Transfer Application, also have attributable interests in broadcast licenses ultimately controlled by TelevisaUnivision. These attributable interests in both HMTV and TelevisaUnivision comply with the Commission's multiple ownership rules, and have already

been approved based on attributable interests that Mr. Zinterhofer and Mr. Frey have long held in both station groups. *See Consent to Transfer Control of Certain Subsidiaries of Univision Holdings, Inc. and Petition for Declaratory Ruling*, Memorandum Opinion and Order and Declaratory Ruling, 35 FCC Rcd 14835 ¶ 23 (2020). The additional interests in HMTV that will be held by Mr. Uzumeri and Mr. Haarmann as a result of the transactions in the HMTV Transfer Application would not change the multiple ownership analysis.

Messrs. Zinterhofer, Uzumeri, Haarmann, and Frey have attributable interests in the following broadcast licenses ultimately controlled by TelevisaUnivision, Inc.:

6. Programming Agreement

Upon the consummation of the Proposed Transaction, the parties intend to enter into a Programming Agreement, under which TelevisaUnivision-controlled entities will be responsible for providing music and other programming to certain of the Stations, subject to HMTV's ultimate control. The Agreement requires the Parties to negotiate and finalize the Programming Agreement before the closing of the Proposed Transaction. The Parties will make available to the Commission or members of the public any agreements required by the Commission's rules.¹²

7. Petition for Declaratory Ruling

As noted above, in connection with the HMTV Transfer Application, Searchlight II HMT has filed the Petition requesting specific approval for certain identified foreign entities and individuals to hold indirect equity and/or deemed voting interests of greater than five percent (or ten percent for certain insulated interests) in HMTV, which will be the indirect parent company of the Licensee. A copy of the Petition is included with this Application.

Because the transaction subject to the HMTV Transfer Application is expected to be consummated immediately prior to or concurrently with the Proposed Transaction in the instant Application, Searchlight II HMT requests that the Commission process the Petition in connection with both transfer of control applications, and include the ownership of the Licensee by HMTV proposed in the Proposed Transaction and this Application, as part of its review of the Petition.

8. Local Radio Ownership Compliance

The Commission's local radio ownership rule uses a tiered approach to determine whether a combination of commonly owned radio stations complies with the local radio ownership limits for any particular market.¹³

The Proposed Transaction will not create any new radio station combinations, as HMTV does not currently hold any radio authorizations. Further, as noted in Section 3

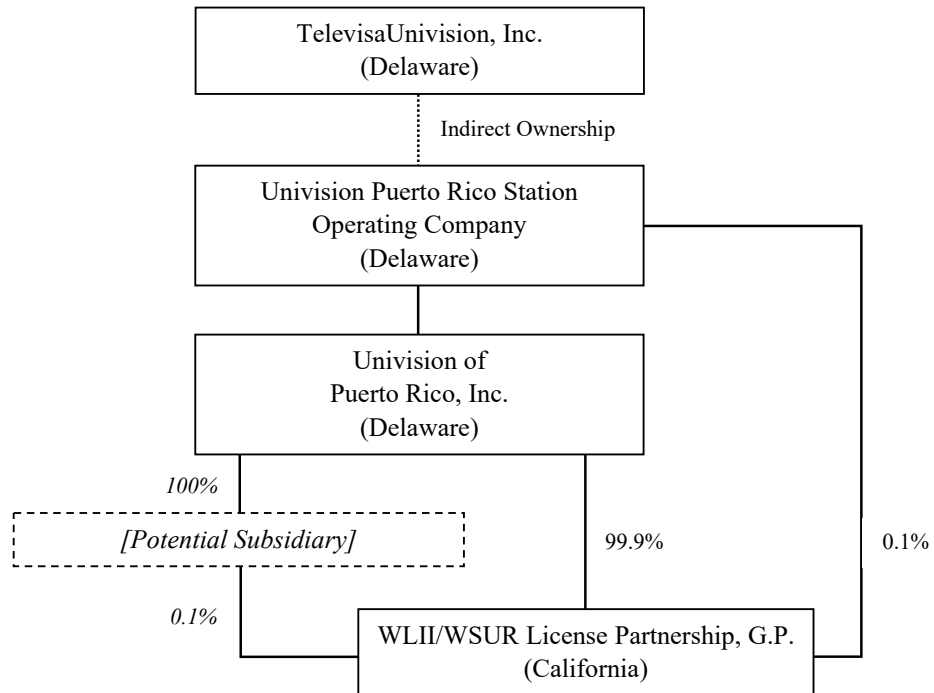
above, individuals that have, or will have, attributable interests in Searchlight II HMT have already been approved to hold attributable interests in TelevisaUnivision and the Stations.¹⁴

As shown in Attachment B, the BIA Geographic Market Definition report for Puerto Rico, the Puerto Rico Nielsen Audio market is home to 131 commercial and noncommercial full-power radio stations. Therefore, common ownership of eight radio stations with no more than five in the same service is permitted. Upon consummation of the Proposed Transaction, HMTV will have an attributable interest in five commercial radio stations (three FM, two AM), which complies with the local radio ownership rule.

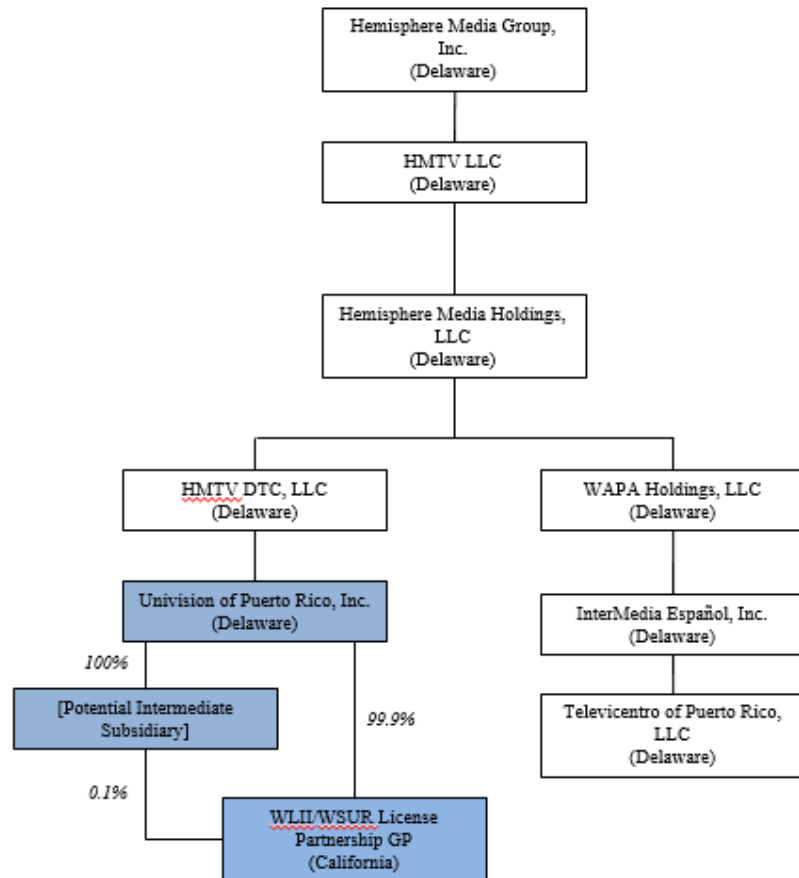

Pre-Transaction Structure (Transferor)



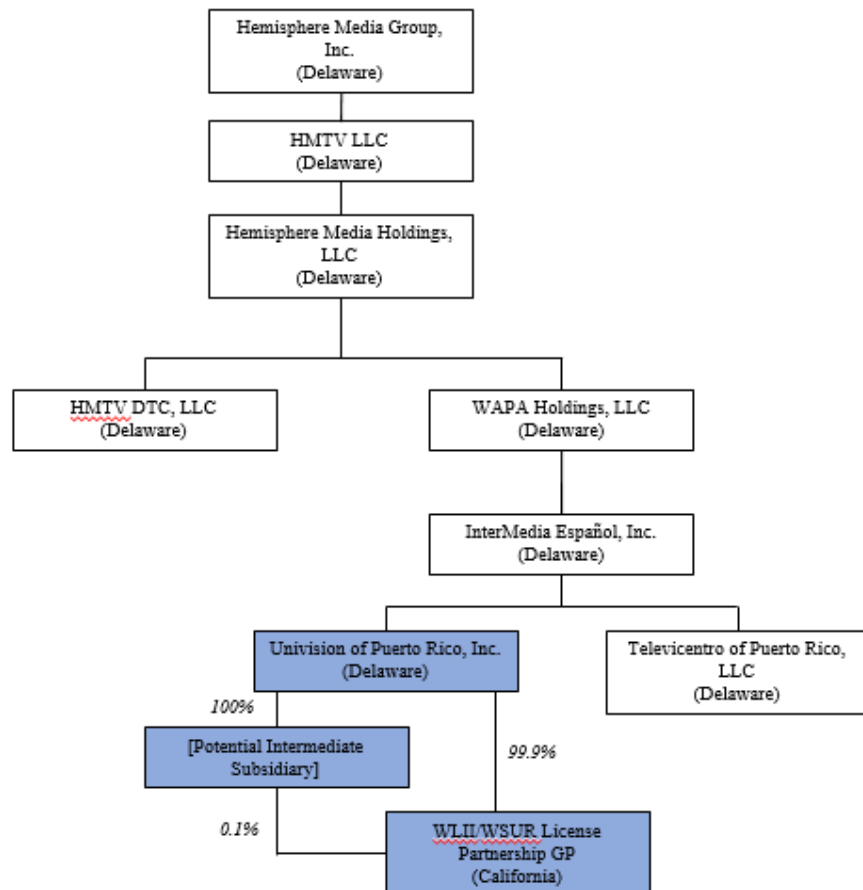
Post-Transaction Structure

Step 1: Transfer of UPRI to HMTV DTC (Buyer)

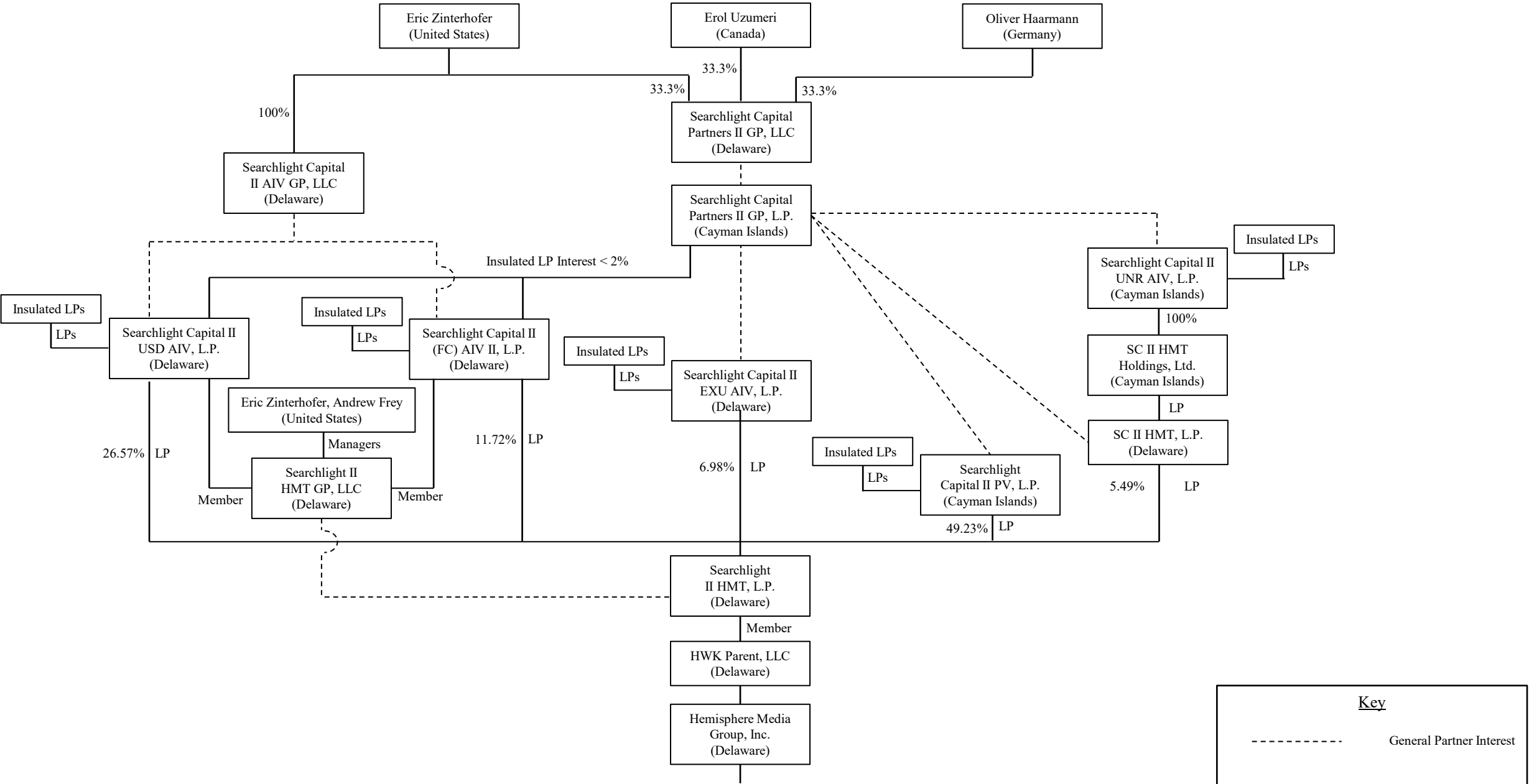


Post-Transaction Structure
