

MULTIPLE OWNERSHIP EXHIBIT

One of the Directors of LPM, Brad Moran (“Moran”), currently holds an attributable interest in Ramar Communications, Inc. (“Ramar”), the licensee of four commercial FM stations and one commercial AM station in the Lubbock, Texas radio market, KRBL’s market.

Under Section 73.3555(a)(1) of the Commission’s rules, the FCC uses a tiered approach to determine whether a combination of commonly owned radio stations complies with the local radio ownership limits for a particular market. As part of its 2015 application for assignment (File No. BALH-20150818ACA), Ramar provided the attached comprehensive BIA study that showed the Lubbock, TX radio market has 31 stations (Exhibit A). Moran, the signatory to this application, has reviewed the prior BIA study and certifies that, as of the filing of this application, there has been no substantial change in the market material to LPM’s compliance with the FCC’s multiple ownership rules.

Should the Commission request additional information about this matter, LPM will provide it.

EXHIBIT A

LOCAL RADIO OWNERSHIP SHOWING

Ramar Communications, Inc. (“Ramar”) hereby demonstrates that grant of the application will be fully consistent with the Commission’s local radio ownership rule. By this application, Ramar proposes to exchange radio station KTTU-FM, Brownfield, Texas, with Barton Broadcasting Company’s radio station KEJS(FM), Lubbock, Texas. Grant of the application will not create an increased concentration of ownership among commonly owned, operated, or controlled media properties. Ramar will continue to own one AM radio station and four FM radio stations in the Lubbock, Texas Nielsen Audio Metro Area post-consummation.

The Commission’s local radio multiple ownership rule provides that in markets with 30 to 44 full-power, commercial and noncommercial radio stations, one party may have a cognizable interest in licenses for not more than seven commercial radio stations, no more than four of which are in the same service (AM or FM). 47 C.F.R. § 73.3555(a)(1)(ii). The Commission defines the relevant market to be the “Arbitron Metro” (now known as the “Nielsen Audio Metro”), in those markets so designated by Nielsen Audio. *See 2002 Biennial Regulatory Review – Review of the Commission’s Broadcast Ownership Rules and Other Rules Adopted Pursuant to Section 202 of the Telecommunications Act of 1996*, 18 FCC Rcd 13620, 13712-13 (2003).

For purposes of the local radio ownership rule, Ramar's owned radio stations, post-consummation, will all be deemed to be part of the Lubbock Nielsen Audio Metro Area.

According to BIA Advisory Service, LLC's *Media Access Pro* database as of June 29, 2015 (*see* the attached *FCC Geographic Market Definition Report for the Lubbock Metro*), there are 31 full-power, commercial and noncommercial radio stations licensed to communities within the Lubbock Metro or which Nielsen designates as "home" to the Lubbock Metro.

Ramar will continue to own one AM radio station and four FM radio stations in the Lubbock, Texas Metro upon a grant of the instant application. For the reasons set forth herein, a grant of this application is fully consistent with the local radio ownership rule.¹

¹ To the extent this Exhibit earlier demonstrates that the FCC's cross-ownership rule (47 C.F.R. § 73.3555(c)(2)(i)(A)) allows Ramar to have cognizable ownership interests in up to two TV stations and six radio stations in the Lubbock Metro (no more than four of which may be in the same service), Ramar's ownership of the identified four FM stations and one AM station in the market post-closing will be compliant.
